AMENDMENTS TO SENATE BILL NO. 10

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, after "Officials" insert "and Law Enforcement Officers"; in line 5, after "officials;" insert "prohibiting a person from knowingly and willfully making certain threats against a law enforcement officer; providing that certain prohibitions against making a certain threat against a certain appointed official apply only to certain threats made during the performance of certain official duties under certain circumstances; defining certain terms;"; and in the same line, after the second "officials" insert "and law enforcement officers".

AMENDMENT NO. 2

On page 1, after line 20, insert:

"(2) (I) "APPOINTED OFFICIAL" MEANS AN INDIVIDUAL SELECTED OR DESIGNATED BY THE GOVERNING BODY OF A COUNTY OR MUNICIPAL CORPORATION OR IN ACCORDANCE WITH THE PROVISIONS FOR APPOINTMENTS IN THE COUNTY OR MUNICIPAL CORPORATION.

(II) "APPOINTED OFFICIAL" INCLUDES A COUNTY OR MUNICIPAL CODE ENFORCEMENT OFFICER OR CODE COMPLIANCE OFFICER.

(3) "LAW ENFORCEMENT OFFICER" MEANS A LAW ENFORCEMENT OFFICER OF A COUNTY OR MUNICIPAL CORPORATION WHO, IN AN OFFICIAL CAPACITY, IS AUTHORIZED BY LAW TO MAKE ARRESTS.";

in line 21, strike "in" and substitute "<u>AS</u>"; in the same line, strike "OR" and substitute "<u>OFFICIAL</u> <u>OR IN A</u>"; and in lines 21 and 24, strike "(2)" and "(3)", respectively, and substitute "<u>(4)</u>" and "<u>(5)</u>", respectively.

On page 2, in line 3, strike "(4)" and substitute "(6)"; and in line 9, after "official" insert "OR A LAW ENFORCEMENT OFFICER".

AMENDMENT NO. 3

On page 2, in line 8, after "(b)" insert "(1)"; in the same line, strike "A" and substitute "SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, A"; and after line 9, insert:

"(2) FOR AN APPOINTED OFFICIAL, THE PROVISIONS OF PARAGRAPH (1) OF THIS SUBSECTION APPLY ONLY TO A THREAT MADE DURING THE PERFORMANCE OF THE OFFICIAL DUTIES OF THE APPOINTED OFFICIAL.".
