AMENDMENTS TO SENATE BILL NO. 632

(First Reading File Bill)

AMENDMENT NO. 1

On page 2, in line 9, strike “largely”.

On page 3, in line 32, after “(4)” insert “THE STATE SUPERINTENDENT OF SCHOOLS OR THE SUPERINTENDENT’S DESIGNEE;

(5)”;

and in the same line, strike “EDUCATION” and substitute “HEALTH AND MENTAL HYGIENE”.

On page 4, in lines 1, 3, and 5, strike “(5)”, “(6)”, and “(7)”, respectively, and substitute “(6)”, “(7)”, and “(8)”, respectively; in line 24, strike “SECRETARY OF EDUCATION OR THE SECRETARY’S” and substitute “STATE SUPERINTENDENT OF SCHOOLS OR THE SUPERINTENDENT’S”; and in line 27, strike “AND”; after line 27, insert:

“(V) THE SECRETARY OF HEALTH AND MENTAL HYGIENE OR THE SECRETARY’S DESIGNEE; AND”;

and in line 28, strike “(V)” and substitute “(VI)”.

AMENDMENT NO. 2

On page 4, in line 5, strike “NINE” and substitute “EIGHTEEN”; in line 16, strike “AND”; in line 17, after “STATE” insert “;

(VI) ONE MEMBER OF A LOCAL MANAGEMENT BOARD;

(VII) ONE MEMBER OF A LOCAL BOARD OF EDUCATION;

(Over)

(VIII) ONE MEMBER WHO IS A REGISTERED FAMILY CHILD CARE PROVIDER WHO SERVES SCHOOL AGE CHILDREN;

(IX) ONE MEMBER WHO IS A STAFF MEMBER OF A LICENSED CHILD CARE CENTER THAT SERVES SCHOOL AGE CHILDREN;

(X) TWO MEMBERS OF THE AFTER-SCHOOL PROVIDER COMMUNITY WHO REPRESENT PROVIDERS NOT INCLUDED IN ITEMS (VIII) AND (IX) OF THIS ITEM;

(XI) ONE MEMBER WHO REPRESENTS THE CONCERNS OF DEVELOPMENTALLY DISABLED CHILDREN; AND

(XII) ONE MEMBER WHO IS A PROFESSIONAL IN THE FIELD OF RECREATION AND PARKS THAT DELIVERS LICENSED OR REGULATED CHILD CARE PROGRAMS”.

On page 6, in line 11, strike “OFFICE” and substitute “MARYLAND PARTNERSHIP”.

AMENDMENT NO. 3

On page 5, in line 35, strike “AT LEAST THREE” and substitute “A MAJORITY OF THE”.

On page 6, in line 2, strike “25%” and substitute “15%”.
