AMENDMENT NO. 1

On page 1, strike beginning with "<u>Four</u>" in line 9 down through "<u>(\$419,509,000)</u>" in line 11 and substitute "<u>Four Hundred Twenty-One Million, Seven Hundred Ninety-Nine Thousand Dollars</u> (<u>\$421,799,000)</u>".

On page 3, in line 23, strike "<u>\$419,509,000</u>" and substitute "<u>\$421,799,000</u>".

On page 4, in line 21, strike "<u>1,800,000</u>" and substitute "<u>2,000,000</u>".

AMENDMENT NO. 3

On page 8, in line 17, after "Institute" insert "<u>, provided that no funds may be expended for</u> the Maryland Fire and Rescue Institute Headquarters facility until the University of Maryland, College Park and Prince George's County have entered into a written agreement whereby the county agrees to provide \$510,000 toward construction of a new headquarters to reimburse a portion of the State's cost of renovating the former Berwyn Heights Elementary School less depreciation. The budget committees shall have 45 days to review and comment on the agreement".
