in line 8, strike "<u>THE ADVISORY</u>" and substitute "<u>EACH</u>"; in line 11, strike "<u>LONG-TERM</u>" and substitute "<u>HEALTH</u>"; strike beginning with "<u>, AT</u>" in line 12 down through "<u>HYGIENE</u>" in line 21 and substitute "<u>;</u>

(II) THREE SHALL BE LICENSED HEALTH PROVIDERS WHO SERVE THE POPULATION REPRESENTED BY THE ADVISORY COMMITTEE;

(III) ONE SHALL BE A REPRESENTATIVE OF THE DEPARTMENT";
