On pages 1 and 2 of the Judiciary Committee Amendments (HB0496/072602/1), strike in their entirety Amendment Nos. 1 through 6, inclusive.

On page 1 of the bill, in line 2, after "Prohibition" insert "- Health Care Professionals"; in line 3, strike beginning with "a" in line 3 down through "Act;" in line 9 and substitute "certain dentists, nurses, pharmacists, physicians, physician assistants, or podiatrists from engaging in certain repetitive acts or a pattern of behavior outside of a certain standard that assists another person to commit or attempt to commit suicide;"; in line 10, strike "defining certain terms;"; in the same line, strike "assisted suicide" and substitute "prohibiting health care professionals from assisting suicide"; and strike in their entirety lines 11 through 15, inclusive, and substitute:

- (28) Fails to cooperate with a lawful investigation conducted by the Board or the Division of Drug Control; OR
- (29) ENGAGES IN REPETITIVE ACTS OR A PATTERN OF BEHAVIOR OUTSIDE THE SCOPE OF ACCEPTED OR REASONABLE MEDICAL PRACTICES THAT ASSISTS ANOTHER PERSON TO COMMIT OR ATTEMPT TO COMMIT SUICIDE.

<u>14-404.</u>

(a) Subject to the hearing provisions of § 14-405 of this subtitle, the Board, on the affirmative vote of a majority of its full authorized membership, may reprimand any licensee, place any licensee on probation, or suspend or revoke a license if the licensee:

- (39) <u>Intentionally misrepresents credentials for the purpose of testifying or rendering an expert opinion in hearings or proceedings before the Board or those otherwise delegated to the Office of Administrative Hearings; [or]</u>
- (40) Fails to keep adequate medical records as determined by appropriate peer review; OR
- (41) ENGAGES IN REPETITIVE ACTS OR A PATTERN OF BEHAVIOR OUTSIDE THE SCOPE OF ACCEPTED OR REASONABLE MEDICAL PRACTICES THAT ASSISTS ANOTHER PERSON TO COMMIT OR ATTEMPT TO COMMIT SUICIDE.

<u>15-314.</u>

Subject to the hearing provisions of § 15-315 of this subtitle, the Board, on the affirmative vote of a majority of its members then serving, may reprimand any certificate holder or suspend or revoke a certificate if the certificate holder:

- (1) Fraudulently or deceptively obtains or attempts to obtain a certificate for the applicant or certificate holder or for another individual;
 - (2) Fraudulently or deceptively uses a certificate;
- (3) Violates any provision of this title or any regulations adopted under this title or commits any act which could serve as the basis for disciplinary action against a physician under § 14-404 of this article;
- (4) Performs delegated medical acts beyond the scope of the certificate not within a job description approved by the Board;
 - (5) Performs delegated medical acts without the supervision of a physician;
- (6) Refuses, withholds from, denies, or discriminates against an individual with regard to the provision of professional services for which the licensee is licensed and qualified to render because the individual is HIV positive;

- (25) Except in an emergency life-threatening situation where it is not feasible or practicable, fails to comply with the Centers for Disease Control's guidelines on universal precautions; [or]
 - (26) Fails to display the notice required under § 16-404 of this title; OR
- (27) ENGAGES IN REPETITIVE ACTS OR A PATTERN OF BEHAVIOR OUTSIDE THE SCOPE OF ACCEPTED OR REASONABLE MEDICAL PRACTICES THAT ASSISTS ANOTHER PERSON TO COMMIT OR ATTEMPT TO COMMIT SUICIDE.".
