AMENDMENT NO. 1

On page 1, strike beginning with "establishing" in line 10 down through "Director;" in line 11; in line 19, strike "changes or new arrangements" and substitute "action necessary"; in line 23, after "circumstances;" insert "repealing the authority of the Secretary to send a written directive to the Insurance Commissioner directing the Insurance Commissioner to take certain actions;"; and strike beginning with "making" in line 31 down through "Secretary;" in line 33.

On page 2, in line 13, strike "19-732,"; and in line 18, after "19-731" insert "and 19-732".

AMENDMENT NO. 2

On page 4, strike in their entirety lines 8 and 9; in lines 10, 12, and 15, strike "(4)", "(5)", and "(6)", respectively, and substitute "(3)", "(4)", and "(5)", respectively; in line 14, after the first "THE" insert "<u>CLINICAL</u>"; strike beginning with "AND" in line 15 down through "DIRECTOR" in line 17, inclusive, and substitute "<u>THE SECRETARY</u>"; and strike in their entirety lines 31 and 32 and substitute:

"(2) MAKE RECOMMENDATIONS TO THE SECRETARY FOR CORRECTIVE ACTION NECESSARY TO MEET THESE REQUIREMENTS.".
