1 AN ACT concerning

2 **State Board of Law Examiners**

3 FOR the purpose of continuing the State Board of Law Examiners by extending to a
4 certain date the termination provisions relating to the statutory and regulatory
5 authority of the Board; requiring that an evaluation of the Board and the
6 statutes and regulations that relate to the Board be performed on or before a
7 certain date; altering the maximum examination fee for applicants for
8 admission to the Bar; requiring the Board to report to certain committees of the
9 General Assembly on or before a certain date; making a certain technical
10 change; and generally relating to the State Board of Law Examiners.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
17 MARYLAND, That the Laws of Maryland read as follows:

18 **Article - Business Occupations and Professions**

19 10-208.

20 (a) An applicant for admission to the Bar shall submit to the Board a petition
21 to the Court of Appeals on the form that the Board provides.

22 (b) An applicant shall pay to the Board:

23 (1) an examination fee not exceeding [\$100] ~~\$200~~ \$150, as set by the
24 Court of Appeals; and

25 (2) any other fee set by the Court of Appeals.

27 Subject to the evaluation and reestablishment provisions of the Maryland
28 Program Evaluation Act, this subtitle shall terminate and be of no effect after [July

32 (d) Except as otherwise provided in subsection (e) of this section, on or before

12 governmental activity or unit, the Legislative Policy Committee, based on a
13 preliminary evaluation, may waive as unnecessary the evaluation required under this
14 section.

15 (K) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION (E) OF THIS SECTION,
16 ON OR BEFORE JULY 1, ~~2014~~ ~~2009~~ 2004, AN EVALUATION SHALL BE MADE OF THE
17 STATE BOARD OF LAW EXAMINERS.

18 SECTION 2. AND BE IT FURTHER ENACTED, That the State Board of Law
19 Examiners shall report to the Senate Judicial Proceedings Committee and the House
20 Judiciary Committee on or before October 1, 1999, in accordance with § 2-1246 of the
21 State Government Article, on ~~the implementation of~~ what, if any, actions the Board
22 has taken in response to the recommendations of the Department of Legislative
23 Services contained in the sunset evaluation report dated October 31, 1998.

24 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
25 July 1, 1999.
