CHAPTER\_\_\_\_\_

1 AN ACT concerning

2 **Crimes - Drug-Induced Conduct**

3 FOR the purpose of prohibiting a person from administering a controlled dangerous  
4 substance or other drug to another without that person's knowledge and with  
5 the intent to commit certain crimes against that person; establishing certain  
6 penalties; establishing that a sentence imposed under this Act may be imposed  
7 separate from and consecutive to or concurrent with a sentence for any offense  
8 based on the act or acts establishing the violation of this Act; defining a certain  
9 term; and generally relating to the administration of certain substances to  
10 another with intent to commit a crime.

21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
22 MARYLAND, That the Laws of Maryland read as follows:

**Article 27 - Crimes and Punishments**

2 277.

3 The following words and phrases as used in this subheading shall have the  
4 following meanings unless the context otherwise requires:

5 (a) "Administer" shall mean to introduce a substance into the system of a  
6 human being or animal by injection, inhalation, ingestion, application to the skin, or  
7 any combination thereof or by any other means.

8 (m) "Drug" means (1) substances recognized in the official United States  
9 Pharmacopoeia, official Homeopathic Pharmacopoeia of the United States, or official  
10 National Formulary, or any supplement to any of them; and (2) substances intended  
11 for use in the diagnosis, cure, mitigation, treatment, or prevention of disease in man  
12 or other animals; and (3) substances (other than food) intended to affect the structure  
13 or any function of the body of man or other animals; and (4) substances intended for  
14 use as a component of any article specified in clause (1), (2), or (3) of this paragraph;  
15 but does not include devices or their components, parts, or accessories.

17 (A) IN THIS SECTION, "DRUG" DOES NOT INCLUDE ALCOHOL.

18 (B) A PERSON MAY NOT ADMINISTER A CONTROLLED DANGEROUS  
19 SUBSTANCE OR OTHER DRUG TO ANOTHER PERSON WITHOUT THAT PERSON'S  
20 KNOWLEDGE AND WITH THE INTENT TO COMMIT AGAINST THAT OTHER PERSON:

21 (1) A CRIME OF VIOLENCE AS DEFINED IN § 643B OF THIS ARTICLE; OR

22 (2) A SEXUAL OFFENSE IN THE THIRD DEGREE UNDER § 464B OF THIS  
23 ARTICLE.

24 (C) (1) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A  
25 MISDEMEANOR AND ON CONVICTION IS SUBJECT TO A FINE OF NOT MORE THAN  
26 \$2,500 OR IMPRISONMENT FOR NOT MORE THAN 1 YEAR OR BOTH.

27 (2) A SENTENCE IMPOSED UNDER THIS SECTION MAY BE IMPOSED  
28 SEPARATE FROM AND CONSECUTIVE TO OR CONCURRENT WITH A SENTENCE FOR  
29 ANY OFFENSE BASED ON THE ACT OR ACTS ESTABLISHING THE VIOLATION OF THIS  
30 SECTION.

32 (a) As used in this section, the term "crime of violence" means abduction;  
33 arson in the first degree; kidnapping; manslaughter, except involuntary  
34 manslaughter; mayhem and maiming, as previously proscribed under §§ 384, 385,  
35 and 386 of this article; murder; rape; robbery; robbery with a deadly weapon;  
36 carjacking or armed carjacking; sexual offense in the first degree; sexual offense in  
37 the second degree; use of a handgun in the commission of a felony or other crime of

1 violence; an attempt to commit any of the aforesaid offenses; assault in the first  
2 degree; and assault with intent to murder, assault with intent to rape, assault with  
3 intent to rob, assault with intent to commit a sexual offense in the first degree, and  
4 assault with intent to commit a sexual offense in the second degree, as these crimes  
5 were previously proscribed under former § 12 of this article.

6 The term "correctional institution" includes Patuxent Institution and a local or  
7 regional jail or detention center.

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
9 October 1, 1999.
