3 FOR the purpose of providing for the issuance of a special sport fishing license for

- 4 display on out-of-state registered boats; providing for a fee for the license; and
- 5 generally relating to the issuance of a special sport fishing license.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

12 MARYLAND, That the Laws of Maryland read as follows:

24 except that such a license may not be used on a boat which has been hired to take

12 paragraph.

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take 14 effect June 1, 1999.
