A BILL ENTITLED

1 AN ACT concerning

2 **State Board for Professional Land Surveyors - License Renewals -**
3 **Continuing Competency Demonstration**

4 FOR the purpose of requiring the State Board for Professional Land Surveyors to
5 adopt regulations to require a demonstration of continuing professional
6 competency for a licensed land surveyor or a licensed property line surveyor to
7 renew a certain license; and generally relating to the renewal of certain licenses
8 by the State Board for Professional Land Surveyors.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
20 MARYLAND, That the Laws of Maryland read as follows:

21 **Article - Business Occupations and Professions**

22 15-101.

23 (a) In this title the following words have the meanings indicated.

24 (b) "Board" means the State Board for Professional Land Surveyors.

25 (d) (1) "License" means, unless the context requires otherwise, a license
26 issued by the Board to practice:

- 1 (i) land surveying; or
- 2 (ii) property line surveying.
- 3 (2) "License" includes, unless the context requires otherwise:
- 4 (i) a license to practice land surveying;
- 5 (ii) a license to practice property line surveying;
- 6 (iii) a limited license issued under § 15-316 of this title; and
- 7 (iv) a temporary license issued under § 15-317 of this title.

8 15-314.

9 (a) Unless a license is renewed for a 2-year term as provided in this section,
10 the license expires on the first June 30 that comes:

- 11 (1) after the effective date of the license; and
- 12 (2) in an odd-numbered year.

13 (b) (1) At least 1 month before a license expires, the Board shall mail to the
14 licensee, at the last known address of the licensee:

- 15 (i) a renewal application form; and
- 16 (ii) a notice that states:
- 17 1. the date on which the current license expires;
- 18 2. the date by which the Board must receive the renewal
19 application for the renewal to be issued and mailed before the license expires; and
- 20 3. the amount of the renewal fee.

21 (2) The failure of a licensee to receive the notice for which this subsection
22 provides does not prevent the license from expiring as specified under subsection (a)
23 of this section.

24 (c) Before a license expires, the licensee periodically may renew it for an
25 additional 2-year term, if the licensee:

- 26 (1) otherwise is entitled to be licensed;
- 27 (2) pays to the Board a renewal fee of:
- 28 (i) \$60 for a license to practice land surveying; or
- 29 (ii) \$40 for a license to practice property line surveying; and

1 (3) submits to the Board a renewal application on the form that the
2 Board provides.

3 (d) (1) The Board shall renew the license of and issue a renewal certificate
4 to each licensee who meets the requirements of this section.

5 (2) The Board shall include on each renewal certificate that the Board
6 issues:

7 (i) the date on which the current license expires; and

8 (ii) the signatures of the chairman and secretary of the Board,
9 under seal of the Board.

10 (e) The Secretary may determine that licenses issued under this subtitle shall
11 expire on a staggered basis.

12 (F) THE BOARD SHALL ADOPT REGULATIONS TO REQUIRE A DEMONSTRATION
13 OF CONTINUING PROFESSIONAL COMPETENCY FOR A LICENSEE AS A CONDITION OF
14 RENEWAL OF A LICENSE UNDER THIS SECTION.

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
16 October 1, 1999.
