1 AN ACT concerning

Vehicle Laws - Allegany County - Golf Carts - Authorization to Cross County Roads

4 FOR the purpose of allowing operation of a golf cart in a certain manner on county

- 5 highways in Allegany County without the golf cart being registered under the
- 6 Maryland Vehicle Law; providing that the Maryland Vehicle Law does not
- 7 preclude the designation of crossings on county highways in Allegany County
- 8 where a person operating a golf cart may cross the highway for continued access
- 9 to any portion of a golf course; and generally relating to the operation of golf
- 10 carts across county roads in Allegany County in proximity of golf courses.

21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

22 MARYLAND, That the Laws of Maryland read as follows:

Article - Transportation

25 (a) (1) Except as otherwise provided in this section or elsewhere in the 26 Maryland Vehicle Law, each motor vehicle, trailer, semitrailer, and pole trailer driven 27 on a highway shall be registered under this subtitle.

28 (c) Registration under this subtitle is not required for:

HOUSE BILL 251 (1)A vehicle that is driven on a highway: In conformity with the provisions of this title relating to (i) 3 manufacturers, transporters, dealers, secured parties, owners or operators of special 4 mobile equipment, or nonresidents; or (ii) Under a temporary registration card issued by the 6 Administration: A vehicle owned and used by the United States, unless an authorized (2)8 officer or employee of the United States requests registration of the vehicle; (3) A farm tractor or any farm equipment; (4) A vehicle the front or rear wheels of which are lifted from the 11 highway; (5) A towed vehicle that is attached to the towing vehicle by a tow bar 13 and for which no driver is necessary; A vehicle owned by and in the possession of a licensed dealer for (6)15 purpose of sale; A vehicle owned by a new resident of this State during the first 30 (7)17 days of his residency provided the vehicle displays valid registration issued by the 18 jurisdiction of his former domicile; (8) New vehicles displaying a shuttle permit issued by the 20 Administration; (9) A vehicle operated in connection with maritime commerce exclusively

22 within any terminal owned or leased by the Maryland Port Administration;

23 A snowmobile which is operated on highways and roadways as (10)24 prescribed by § 25-102(a)(14) of this article;

A golf cart which is operated on a highway on Smith Island, provided 25 (11)26 that the golf cart is equipped with lighting devices as required by the Administration 27 if it is operated on a highway between dusk and dawn; [or]

A GOLF CART WHICH IS OPERATED ON AN ALLEGANY COUNTY 28 (12)29 HIGHWAY AS ALLOWED BY THE COUNTY UNDER § 25-102(A)(16) OF THIS ARTICLE; OR

A vehicle owned by an accredited consular or diplomatic officer of a 30 (13)

31 foreign government and operated for official or personal purposes when the vehicle

32 displays a valid diplomatic license plate issued by the United States government.
