Meade Military 4 Reservation and located in Anne Arundel County; providing a description of the 5 property; providing that the State retains the right to serve all civil and criminal 6 process of the courts of this State; providing for enforcement of certain 7 environmental laws State laws and regulations; providing for the effective date 8 9 of this Act; and generally relating to a grant of exclusive jurisdiction to the 10 United States. 11 BY repealing and reenacting, with amendments, Article - State Government 12 13 Section 14-102 14 Annotated Code of Maryland (1995 Replacement Volume and 1998 Supplement) 15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 16 17 MARYLAND, That the Laws of Maryland read as follows: 18 **Article - State Government** 19 14-102. 20 With respect to land that the United States or any of its units leases or

21 otherwise holds in the State, the State reserves jurisdiction and authority over the 22 land and over persons, property, and transactions on the land to the fullest extent

- 1 that is permitted by the United States Constitution and that is not inconsistent with
- 2 the governmental purpose for which the land is held.
- 3 (b) This section does not affect the jurisdiction and authority of the State over
- 4 land or persons, property, and transactions on land that the United States or its unit
- 5 has acquired on or before May 31, 1943 to the extent that the State ceded jurisdiction
- 6 under:
- 7 (1) Chapter 193, §§ 3 and 4, of the Acts of the General Assembly of 1874;
- 8 (2) Chapter 395, §§ 13 and 14, of the Acts of the General Assembly of
- 9 1874;
- 10 (3) Chapter 67, § 21, of the Acts of the General Assembly of 1900;
- 11 (4) Chapter 743, §§ 2 and 3, of the Acts of the General Assembly of 1906;
- 12 (5) Chapter 194 of the Acts of the General Assembly of 1908; or
- 13 (6) any other act that gave consent for the acquisition of property and
- 14 ceded jurisdiction with respect to that property.
- 15 (c) Notwithstanding subsection (a) of this section, for the purpose of enforcing
- 16 the civil or criminal laws of the State, the Governor may enter into agreements with
- 17 the United States to establish full or partial concurrent jurisdiction by the State and
- 18 the United States over any lands in the State held by the United States.
- 19 (D) (1) EXCEPT AS PROVIDED IN PARAGRAPH (3) OF THIS SUBSECTION, AND
- 20 FOR AS LONG AS THE UNITED STATES SHALL OWN SUCH LAND, THE STATE CEDES
- 21 EXCLUSIVE JURISDICTION TO THE UNITED STATES OVER ALL THAT CERTAIN TRACT
- 22 OR PARCEL OF LAND SITUATE IN THE STATE OF MARYLAND, ANNE ARUNDEL
- 23 COUNTY, BEING A PORTION OF THE FORT GEORGE G. MEADE MILITARY
- 24 RESERVATION, LANDS OWNED BY THE UNITED STATES OF AMERICA AS DESIGNATED
- 25 BY TRACT NUMBERS 170-1, 171, 172 AND 174, COMPRISING APPROXIMATELY 265 ACRES
- 26 AND HEREINAFTER REFERRED TO BY THE TRACT NUMBER AND MORE
- 27 PARTICULARLY BOUNDED AND DESCRIBED AS FOLLOWS:
- 28 BEGINNING AT CONCRETE MONUMENT NUMBER 77 IN THE FORT GEORGE G.
- 29 MEADE MILITARY RESERVATION BOUNDARY LINE, BEING AN ORIGINAL CORNER OF
