2 Frederick County - Lamar Sanitarium - Historic Museum Loan of 1996

- 3 FOR the purpose of amending Chapter 280 of the Acts of the General Assembly of
- 4 1996, the Frederick County Lamar Sanitarium Historic Museum Loan of
- 5 1996, to extend the time by which the Board of Directors of the Central
- 6 Maryland Heritage League, Inc. shall present certain evidence of a matching
- 7 fund to the Board of Public Works.
- 8 BY repealing and reenacting, with amendments,
- 9 Chapter 280 of the Acts of the General Assembly of 1996
- 10 Section 1
- 11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 12 MARYLAND, That the Laws of Maryland read as follows:

13 Chapter 280 of the Acts of 1996

- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 15 MARYLAND, That:
- 16 (1) The Board of Public Works may borrow money and incur indebtedness on
- 17 behalf of the State of Maryland through a State loan to be known as the Frederick
- 18 County Lamar Sanitarium Historic Museum Loan of 1996 in a total principal
- 19 amount equal to the lesser of (i) \$100,000 or (ii) the amount of the matching fund
- 20 provided in accordance with Section 1(5) below. This loan shall be evidenced by the
- 21 issuance, sale, and delivery of State general obligation bonds authorized by a
- 22 resolution of the Board of Public Works and issued, sold, and delivered in accordance
- 23 with §§ 8-117 through 8-124 of the State Finance and Procurement Article and
- 24 Article 31, § 22 of the Code.
- 25 (2) The bonds to evidence this loan or installments of this loan may be sold as
- 26 a single issue or may be consolidated and sold as part of a single issue of bonds under
- 27 § 8-122 of the State Finance and Procurement Article.
- 28 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer
- 29 and first shall be applied to the payment of the expenses of issuing, selling, and

- 1 delivering the bonds, unless funds for this purpose are otherwise provided, and then
- 2 shall be credited on the books of the Comptroller and expended, on approval by the
- 3 Board of Public Works, for the following public purposes, including any applicable
- 4 architects' and engineers' fees: as a grant to the Board of Directors of the Central
- 5 Maryland Heritage League, Inc. (referred to hereafter in this Act as "the grantee") for
- 6 the acquisition, repair, and renovation of a historic building known as Dr. Lamar's
- 7 Sanitarium, a facility formerly used for the medical and surgical treatment of
- 8 patients, which facility is located in Frederick County and has been designated as a
- 9 historic landmark, the facility to be used as a historical museum with associated
- 10 offices.
- 11 (4) An annual State tax is imposed on all assessable property in the State in
- 12 rate and amount sufficient to pay the principal of and interest on the bonds, as and
- 13 when due and until paid in full. The principal shall be discharged within 15 years
- 14 after the date of issuance of the bonds.
- 15 (5) Prior to the payment of any funds under the provisions of this Act for the
- 16 purposes set forth in Section 1(3) above, the grantee shall provide and expend a
- 17 matching fund. No part of the grantee's matching fund may be provided, either
- 18 directly or indirectly, from funds of the State, whether appropriated or
- 19 unappropriated. No part of the fund may consist of real property, in kind
- 20 contributions, or funds expended prior to the effective date of this Act. In case of any
- 21 dispute as to the amount of the matching fund or what money or assets may qualify
- 22 as matching funds, the Board of Public Works shall determine the matter and the
- 23 Board's decision is final. The grantee has until June 1, [1998,] 2000, to present
- 24 evidence satisfactory to the Board of Public Works that a matching fund will be
- 25 provided. If satisfactory evidence is presented, the Board shall certify this fact and
- 26 the amount of the matching fund to the State Treasurer, and the proceeds of the loan
- 27 equal to the amount of the matching fund shall be expended for the purposes provided
- 28 in this Act. Any amount of the loan in excess of the amount of the matching fund
- 29 certified by the Board of Public Works shall be canceled and be of no further effect.
- 30 Prior to the issuance of the bonds, the grantee shall grant and convey
- 31 to the Maryland Historical Trust a perpetual preservation easement to the extent of
- 32 its interest:
- 33 (i) On the land or such portion of the land acceptable to the Trust;
- 34 and
- 35 On the exterior and interior, where appropriate, of the historic (ii)
- 36 structures.
- 37 (b) The easement must be in form and substance acceptable to the Trust
- 38 and the extent of the interest to be encumbered must be acceptable to the Trust.
- 39 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 40 June 1, 1999.
