(1) An additional payment of two dollars (\$2.) per month shall be added to the benefits described in Subsection B of this section for each full year of volunteer service in excess of twenty-five (25) years. Beginning July 1, 1984, and annually thereafter, this amount shall be increased or decreased by an amount equal to the annual increase or decrease as reflected by the consumer price index, using the
