- 21 LAWS, WHICH IS ADMINISTERED BY A NONPROFIT ORGANIZATION COMPOSED OF
- 22 AND CONTROLLED BY STATE NURSE LICENSING BOARDS.
- 23 (E) "CURRENT SIGNIFICANT INVESTIGATIVE INFORMATION" MEANS
- 24 INVESTIGATIVE INFORMATION THAT:
- 25 (1) A LICENSING BOARD, AFTER A PRELIMINARY INQUIRY THAT
- 26 INCLUDES NOTIFICATION AND AN OPPORTUNITY FOR THE NURSE TO RESPOND IF
- 27 REQUIRED BY STATE LAW, HAS REASON TO BELIEVE IS NOT GROUNDLESS AND, IF
- 28 PROVED TRUE, WOULD INDICATE MORE THAN A MINOR INFRACTION; OR
- 29 (2) INDICATES THAT THE NURSE REPRESENTS AN IMMEDIATE THREAT
- 30 TO PUBLIC HEALTH AND SAFETY REGARDLESS OF WHETHER THE NURSE HAS BEEN
- 31 NOTIFIED AND HAS HAD AN OPPORTUNITY TO RESPOND.
- 32 (F) "HOME STATE" MEANS THE PARTY STATE THAT IS THE NURSE'S PRIMARY
- 33 STATE OF RESIDENCE.
- 34 (G) (1) "HOME STATE ACTION" MEANS ANY ADMINISTRATIVE, CIVIL,
- 35 EQUITABLE, OR CRIMINAL ACTION PERMITTED BY THE LAWS OF THE HOME STATE
- 36 WHICH ARE IMPOSED ON A NURSE BY THE LICENSING BOARD OF THE HOME STATE.

- 1 (2) "HOME STATE ACTION" INCLUDES:
- 2 (I) REVOCATION OF A LICENSE;
- 3 (II) SUSPENSION OF A LICENSE;
- 4 (III) PROBATION OF A LICENSEE; OR
- 5 (IV) ANY OTHER ACTION WHICH AFFECTS A NURSE'S
- 6 AUTHORIZATION TO PRACTICE.
- 7 (H) "MULTISTATE LICENSING PRIVILEGE" MEANS THE CURRENT, OFFICIAL
- 8 AUTHORITY FROM A REMOTE STATE PERMITTING THE PRACTICE OF NURSING AS
- $9\,$ EITHER A REGISTERED NURSE OR A LICENSED PRACTICAL OR VOCATIONAL NURSE
- 10 IN A PARTY STATE.
- 11 (I) "NURSE" MEANS A REGISTERED NURSE OR A LICENSED PRACTICAL OR
- 12 VOCATIONAL NURSE AS THOSE TERMS ARE DEFINED BY THE LAWS OF EACH PARTY
- 13 STATE.
- 14 (J) "PARTY STATE" MEANS ANY STATE THAT HAS ADOPTED THIS COMPACT.
- 15 (K) "REMOTE STATE" MEANS A PARTY STATE, OTHER THAN THE HOME STATE:
- 16 (1) WHERE THE PATIENT IS LOCATED AT THE TIME NURSING CARE IS
- 17 PROVIDED; OR
- 18 (2) IN THE CASE OF THE PRACTICE OF NURSING THAT DOES NOT
- 19 INVOLVE A PATIENT, IN THE PARTY STATE WHERE THE RECIPIENT OF NURSING
- 20 PRACTICES IS LOCATED.
- 21 (L) "REMOTE STATE ACTION" MEANS ANY:
- 22 (1) ADMINISTRATIVE, CIVIL, EQUITABLE, OR CRIMINAL ACTION
- 23 PERMITTED BY THE LAWS OF THE REMOTE STATE WHICH ARE IMPOSED ON A NURSE
- 24 BY THE LICENSING BOARD OF THE REMOTE STATE OR OTHER AUTHORITY,
- 25 INCLUDING ACTIONS AGAINST AN INDIVIDUAL'S MULTISTATE LICENSING PRIVILEGE
- 26 TO PRACTICE IN THE REMOTE STATE; AND
- 27 (2) CEASE AND DESIST OR OTHER INJUNCTIVE OR EQUITABLE ORDERS
- 28 ISSUED BY REMOTE STATES OR THEIR LICENSING BOARDS.
- 29 (M) "STATE" MEANS A STATE, TERRITORY, OR POSSESSION OF THE UNITED
- 30 STATES. THE DISTRICT OF COLUMBIA. OR THE COMMONWEALTH OF PUERTO RICO.
- 31 (N) (1) "STATE PRACTICE LAWS" MEANS THOSE INDIVIDUAL PARTY STATE'S
- 32 LAWS AND REGULATIONS THAT GOVERN THE PRACTICE OF NURSING, DEFINE THE
- 33 SCOPE OF NURSING PRACTICE, AND CREATE THE METHODS AND GROUNDS FOR

- 7 A LICENSE TO PRACTICE REGISTERED NURSING ISSUED BY A HOME STATE TO A
- 8 RESIDENT OF THAT STATE WILL BE RECOGNIZED BY EACH PARTY STATE AS
- 9 AUTHORIZATION FOR A MULTISTATE LICENSING PRIVILEGE TO PRACTICE AS A
- 10 REGISTERED NURSE IN A PARTY STATE. A LICENSE TO PRACTICE LICENSED

- 28 SYSTEM SHALL PROMPTLY NOTIFY THE HOME STATE OF ANY SUCH ACTIONS BY

- 31 (A) EVERY NURSE PRACTICING IN A PARTY STATE MUST COMPLY WITH THE
- 32 STATE PRACTICE LAWS OF THE STATE IN WHICH THE PATIENT IS LOCATED AT THE
- 33 TIME THAT CARE IS RENDERED. IN ADDITION, THE PRACTICE OF NURSING IS NOT
- 34 LIMITED TO PATIENT CARE, BUT SHALL INCLUDE ALL PRACTICES OF NURSING, AS
- 35 DEFINED BY THE LAWS OF A PARTY STATE. THE PRACTICE OF NURSING WILL
- 36 SUBJECT A NURSE TO THE JURISDICTION OF THE NURSE LICENSING BOARD AND

- 38 (B) THIS NURSE MULTISTATE LICENSURE COMPACT DOES NOT AFFECT
- 39 ADDITIONAL REQUIREMENTS IMPOSED BY STATES FOR ADVANCED PRACTICE
- 40 REGISTERED NURSING. HOWEVER, A MULTISTATE LICENSING PRIVILEGE TO
- 41 PRACTICE REGISTERED NURSING GRANTED BY A PARTY STATE SHALL BE

- 1 RECOGNIZED BY OTHER PARTY STATES AS A LICENSE TO PRACTICE REGISTERED
- 2 NURSING IF ONE IS REQUIRED BY STATE LAW AS A PRECONDITION FOR QUALIFYING
- 3 FOR ADVANCED PRACTICE REGISTERED NURSE AUTHORIZATION.
- 4 (C) INDIVIDUALS NOT RESIDING IN A PARTY STATE SHALL CONTINUE TO BE
- 5 ABLE TO APPLY FOR NURSE LICENSURE AS PROVIDED BY THE LAWS OF EACH PARTY
- 6 STATE. HOWEVER, THE LICENSE GRANTED TO THE INDIVIDUALS MAY NOT BE
- 7 RECOGNIZED AS GRANTING THE PRIVILEGE TO PRACTICE NURSING IN ANY OTHER
- 8 PARTY STATE UNLESS EXPLICITLY AGREED TO BY THAT PARTY STATE.

- 11 (A) UPON APPLICATION FOR A LICENSE, THE LICENSING BOARD IN A PARTY
- 12 STATE SHALL ASCERTAIN, THROUGH THE COORDINATED LICENSURE INFORMATION
- 13 SYSTEM, WHETHER:
- 14 (1) THE APPLICANT HAS EVER HELD, OR IS THE HOLDER OF, A LICENSE
- 15 ISSUED BY ANY OTHER STATE;
- 16 (2) THERE ARE ANY RESTRICTIONS ON THE MULTISTATE LICENSE
- 17 PRIVILEGE; AND
- 18 (3) ANY OTHER ADVERSE ACTION BY ANY STATE HAS BEEN TAKEN
- 19 AGAINST THE LICENSEE.
- 20 (B) A NURSE IN A PARTY STATE SHALL HOLD LICENSURE IN ONLY ONE PARTY
- 21 STATE AT A TIME, ISSUED BY THE HOME STATE.
- 22 (C) A NURSE WHO INTENDS TO CHANGE PRIMARY STATE OF RESIDENCE MAY
- 23 APPLY FOR LICENSURE IN THE NEW HOME STATE IN ADVANCE OF SUCH A CHANGE,
- 24 PROVIDED THAT THE NURSE SUBMITS EVIDENCE OF THE CHANGE IN PRIMARY
- 25 STATE OF RESIDENCE THAT IS SATISFACTORY TO THE NEW HOME STATE'S
- 26 LICENSING BOARD.
- 27 (D) WHEN A NURSE CHANGES PRIMARY STATE OF RESIDENCE BY MOVING:
- 28 (1) BETWEEN TWO PARTY STATES AND OBTAINS A LICENSE FROM THE
- 29 NEW HOME STATE, THE LICENSE FROM THE FORMER HOME STATE IS NO LONGER
- 30 VALID;
- 31 (2) FROM A NONPARTY STATE TO A PARTY STATE AND OBTAINS A
- 32 LICENSE FROM THE NEW HOME STATE. THE INDIVIDUAL STATE LICENSE ISSUED BY
- 33 THE NONPARTY STATE WILL REMAIN IN FULL FORCE AND EFFECT, SUBJECT TO THE

- 35 (3) FROM A PARTY STATE TO A NONPARTY STATE, THE LICENSE ISSUED

- 5 IN ADDITION TO THE GENERAL PROVISIONS CONTAINED IN ARTICLE III, THE 6 FOLLOWING PROVISIONS APPLY:
- 7 (A) THE LICENSING BOARD OF A REMOTE STATE SHALL PROMPTLY NOTIFY
- 8 THE ADMINISTRATOR OF THE COORDINATED LICENSURE INFORMATION SYSTEM OF
- 9 ANY REMOTE STATE ACTIONS, INCLUDING THE FACTUAL AND LEGAL BASIS FOR
- 10 SUCH ACTION, IF KNOWN, AND REPORT ANY SIGNIFICANT CURRENT INVESTIGATIVE
- 11 INFORMATION YET TO RESULT IN A REMOTE STATE ACTION. THE ADMINISTRATOR
- 12 OF THE COORDINATED LICENSURE INFORMATION SYSTEM SHALL PROMPTLY
- 13 NOTIFY THE HOME STATE OF ANY SUCH REMOTE STATE ACTIONS.
- 14 (B) THE LICENSING BOARD OF A PARTY STATE SHALL HAVE THE AUTHORITY
- 15 TO COMPLETE ANY PENDING INVESTIGATIONS FOR A NURSE WHO CHANGES THE
- 16 PRIMARY STATE OF RESIDENCE DURING THE COURSE OF AN INVESTIGATION. IT
- 17 SHALL ALSO HAVE THE AUTHORITY TO TAKE THE NECESSARY ACTION OR ACTIONS,
- 18 AND SHALL PROMPTLY REPORT THE CONCLUSIONS OF THE INVESTIGATION TO THE
- 19 ADMINISTRATOR OF THE COORDINATED LICENSURE INFORMATION SYSTEM. THE
- 20 ADMINISTRATOR OF THE COORDINATED LICENSURE INFORMATION SYSTEM SHALL
- 21 PROMPTLY NOTIFY THE NEW HOME STATE OF ANY SUCH ACTIONS.
- 22 (C) A REMOTE STATE MAY TAKE AN ADVERSE ACTION AFFECTING THE
- 23 MULTISTATE LICENSING PRIVILEGE TO PRACTICE WITHIN THAT PARTY STATE.
- 24 HOWEVER, ONLY THE HOME STATE SHALL HAVE THE POWER TO IMPOSE AN
- 25 ADVERSE ACTION AGAINST THE LICENSE ISSUED BY THE HOME STATE.
- 26 (D) FOR PURPOSES OF IMPOSING AN ADVERSE ACTION, THE LICENSING
- 27 BOARD OF THE HOME STATE SHALL GIVE THE SAME PRIORITY AND EFFECT TO THE
- 28 REPORTED CONDUCT RECEIVED FROM A REMOTE STATE AS IT WOULD IF THE
- 29 CONDUCT HAD OCCURRED IN THE HOME STATE. IN DOING SO, THE HOME STATE
- 30 SHALL APPLY ITS OWN STATE LAWS TO DETERMINE THE APPROPRIATE ACTION TO
- 31 TAKE AGAINST THE LICENSEE.
- 32 (E) THE HOME STATE MAY TAKE AN ADVERSE ACTION BASED ON THE
