3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

4 MARYLAND, That the Laws of Maryland read as follows:

5 Article 65 - Militia

6 1.

- All able-bodied citizens of the State and all able-bodied persons of foreign birth,
- 8 who have declared their intentions to become citizens of the State, and who are
- 9 residents therein, shall constitute the militia, subject to the following exemptions: (1)
- 10 persons exempted by the laws of the United States; (2) persons exempted by the laws
- 11 of Maryland; (3) the members of any regularly organized fire or police department in
- 12 any COUNTY, city, village or town; (4) judges and clerks of courts of record, registers of
- 13 wills and deeds, sheriffs, [ministers of the Gospel, members of religious communities,
- 14 ecclesiastical students in the various seminaries and schools of divinity,] CLERGY,
- 15 practicing physicians, superintendents, officers and assistants of hospitals, prisons
- 16 and jails; [all persons actually employed as teachers in any established school, college
- 17 or university; lighthouse keepers, conductors and engineers of railways, seamen
- 18 actually employed as such; idiots, lunatics, paupers, vagabonds, confirmed
- 19 drunkards, [(5) ADJUDICATED INCOMPETENTS, persons addicted to the use of
- 20 narcotic drugs, and persons convicted of infamous crimes[; all]. ALL such exempted
- 21 persons, except as enumerated in items (1) and [(2)] (2), shall be available for military
- 22 duty in case of war, insurrection, invasion or imminent danger thereof. Whenever the
- 23 masculine gender is used in this article, it also includes the feminine gender, unless
- 24 otherwise provided by law.

25 2.

- 26 When the militia of this State, or any part thereof, is called or ordered under the
- 27 Constitution and laws of the United States, into the active military service of the
- 28 United States, the Governor [shall] MAY order out for service the organized militia,
- 29 or such part thereof as may be necessary [and if]. IF the number available [be] IS
- 30 insufficient [he shall], THE GOVERNOR MAY order out such part of the unorganized
- 31 militia as he may deem necessary.

32 [3.

- Whenever any portion of the militia shall be on duty pursuant to the orders of
- 34 the Governor, or shall be on duty or ordered to assemble for duty in time of war,
- 35 insurrection, invasion, public danger or to aid the civil authorities on account of any
- 36 breach of the peace, tumult, riot, resistance to process of this State, or imminent
- 37 danger thereof, or for any other cause, the articles of war governing the Army of the
- 38 United States, as well as such regulations issued thereunder, shall be in force and
- 39 regarded as part of this article until said forces shall be duly relieved from such duty.
- 40 As to offenses committed when such articles of war are in force, courts-martial shall
- 41 possess, in addition to the jurisdiction and power of sentence and punishment therein

- 1 vested to them, all additional jurisdiction and power of sentence and punishment
- 2 exercisable by like courts under such articles of war or the regulations and laws
- 3 governing the Army of the United States, or the customs and usages thereof; but no
- 4 punishment under such rules and articles, which shall extend to the taking of life,
- 5 shall in any case be inflicted, except in time of actual war, invasion or insurrection,
- 6 and then only after the approval by the Governor of the sentence inflicting such
- 7 punishment. Imprisonment other than in guardhouse shall be executed in jails or
- 8 prisons designated by the Governor for the purpose.]

9 4.

- 10 Every member of the UNORGANIZED militia ordered out, or who volunteers, who
- 11 does not appear at the time and place designated by his commanding officer [or the
- 12 sheriff aforesaid within twenty-four hours from such time, or who does not produce a
- 13 sworn certificate of physical disability, to so appear, from a physician in good
- 14 standing, shall be taken to be a deserter and dealt with as prescribed in the articles of
- 15 war, Army of the United States] SHALL BE SUBJECT TO COURT-MARTIAL UNDER
- 16 THIS ARTICLE.



- 18 (A) The militia of this State shall be divided into two classes: The organized
- 19 militia and the unorganized militia.
- 20 (B) The organized militia of the State shall consist of [officers appointed and
- 21 commissioned by the Governor, and of such able-bodied citizens of the State, and such
- 22 able-bodied persons of foreign birth as have declared their intentions to become
- 23 citizens of the State, resident therein, as shall be regularly enlisted therein, including
- 24 the National Guard, the Maryland Defense Force and the reserve militia (Minute
- 25 Men)] THE MARYLAND ARMY NATIONAL GUARD, THE MARYLAND AIR NATIONAL
- 26 GUARD, THE INACTIVE NATIONAL GUARD, AND THE MARYLAND DEFENSE FORCE. A
- 27 military office for which no salary is provided in the budget shall not be considered an
- 28 office of profit.
- 29 (C) The unorganized militia shall consist of all those liable to serve but not
- 30 regularly enlisted OR COMMISSIONED IN THE ORGANIZED MILITIA.

- 32 [The several sections of this article that are applicable to the naval militia
- 33 organized under § 3-303 of the State Government Article shall have the same force
- 34 and effect as if the term naval militia had been specifically designated in any or all of
- 35 such sections.]
- 36 (A) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, THE ADJUTANT
- 37 GENERAL MAY APPOINT:
- 38 (1) AN EXECUTIVE OFFICER;

They shall be entitled to 22 receive the same per diem pay, including longevity pay, subsistence and allowances, 23 as officers, warrant officers and enlisted [men] PERSONS of like grades and length of 24 service in the regular army or air force, as the case may be. Subsistence and 25 allowances shall be accorded the same treatment for income tax purposes under the 26 laws of this State as granted by the United States Internal Revenue Code, and 27 regulations promulgated thereunder for federal income tax purposes; and such 28 subsistence and allowances shall not be used in calculating the salary base for 29 retirement purposes for any employee who is a member of the Employees' Retirement 30 System of the State of Maryland. 31 An individual who holds more than one of the above-mentioned offices 32 simultaneously shall receive only the pay allowances and subsistence provided herein 33 for a single office.

The Governor may choose a staff consisting of the Adjutant General, and

35 not more than twelve aides. The aides will be selected by the Governor from among 36 the commissioned officers of the National Guard and naval militia. Each of them may 37 receive an appointment as aide, which however, shall not add to the actual grade of 38 the officer so appointed; nor shall such officer be relieved from duty with the

- 1 organization to which he is assigned, except when actually on duty as aide under the 2 orders of the Governor.]
- 3 [(h)] (G) The appointment of a chief of staff and aides shall be at the pleasure 4 of the Governor.
- 5 [(i)] (H) A Deputy Assistant Adjutant General for Army shall be appointed by
- 6 the Governor and [his term of office shall be at the pleasure of the Governor] SERVE
- 7 AT THE PLEASURE OF THE ADJUTANT GENERAL. The Deputy Assistant Adjutant
- 8 General for Army shall have a commissioned grade not above that of Brigadier
- 9 General and shall perform the military duties assigned by the Governor or by the
- 10 Adjutant General.
- 11 (I) THE ADJUTANT GENERAL, THE ASSISTANT ADJUTANT GENERAL FOR
- 12 ARMY, AND THE ASSISTANT ADJUTANT GENERAL FOR AIR EACH SHALL BE
- 13 FULL-TIME EMPLOYEES OF THE MILITARY DEPARTMENT.
- 14 (J) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, THE ADJUTANT
- 15 GENERAL SHALL BE A MEMBER OF THE GOVERNOR'S CABINET.

- 17 The Governor of Maryland may assign to the Adjutant General, for such period
- 18 as designated, the duty of serving as acting police commissioner of the Mayor and
- 19 City Council of Baltimore, with all the powers, duties, and functions prescribed and
- 20 provided by law for that position. For any period during which this duty is assigned to
- 21 and discharged by the Adjutant General, the Mayor and City Council of Baltimore
- 22 shall pay over to the general funds of the State treasury a sum computed on the basis
- 23 of two thousand dollars for each month. The provisions of this section, and the
- 24 appointment shall expire automatically as of May 31, 1967, with no further action
- 25 required by the General Assembly, except that sums due as of that date for the said
- 26 two thousand dollars per month payments shall be paid over to the general funds of
- 27 the State after that time, as if this section had not automatically expired.]

- 29 The Adjutant General, as Quartermaster General, shall be responsible to the
- 30 Governor for the care, preservation and safekeeping of all military property. He shall

- 33 expenses incurred in the upkeep of the militia and such expenses shall be audited and
- 34 paid in the manner provided by law. He shall make such purchases and issue such

34	There shall be an unassigned list exclusively restricted to officers and enlisted men of the organized militia and none other, who are transferred thereto by the Governor; provided that such transfer shall not in anywise be considered a removal from office or affect the rank of an officer or enlisted man so transferred.]

- No officer of the militia shall incur any expense whatever to be paid by the
- 3 State, except such as authorized in this article, without first obtaining the authority
- 4 of the Adjutant General. In [extreme emergencies] STATE ACTIVE DUTY, however,
- 5 the commanding officer of any organization or detachment of the organized militia
- 6 may purchase such necessities as are absolutely required for the immediate use and
- 7 care of his command, taking receipts in triplicate therefor; a report of such action,
- 8 containing a statement of the articles purchased and the price thereof, with the
- 9 receipts attached, must be made forthwith through the regular channels to the
- 10 [Quartermaster General] MILITARY DEPARTMENT FINANCE OFFICER. The
- 11 Comptroller of the State shall be the auditor of all accounts for property purchased by
- 12 the Adjutant General. All other military accounts payable by the State shall be
- 13 audited by the Adjutant General. Military accounts thus audited shall be paid by the
- 14 Treasurer of the State from a proper appropriation made by the legislature, upon the
- 15 warrant of the Adjutant General, under and by direction of the Governor.

- 17 (b) In addition to State active duty benefits, the Adjutant General shall
- 18 maintain workers' compensation insurance for members of the Maryland [State
- 19 Guard] DEFENSE FORCE during training.
- 20 23.
- 21 A commissioned officer tendering [his] A resignation, if accepted by the
- 22 Governor, shall receive an honorable discharge, provided [he] THE OFFICER shall not
- 23 be under arrest or returned to a military court for any deficiency or delinquency; and
- 24 provided further, [he] THE OFFICER be not indebted to the State in any manner, and
- 25 that [his] THE OFFICER'S accounts for money or for public property be correct. If the
- 26 Governor [accept] ACCEPTS the resignation of an officer who at the time shall be
- 27 under arrest, under charges or returned to a military court for any offense, deficiency
- 28 or delinquency, such officer shall then cease to be an officer and shall receive a
- 29 discharge in such form as the Governor shall direct; nor shall [he] THE OFFICER be
- 30 again eligible to receive a commission unless [he] THE OFFICER first reenlist and
- 31 until [he] THE OFFICER shall have performed at least [60] 100 percent of duty in
- 32 each year under such enlistment for [two] 2 successive years.

- 34 Any able-bodied [male who is a] citizen of the State, or PERSON WHO has
- 35 declared [his] AN intention to become a citizen of the State, of good character and
- 36 temperate habits, may be enlisted in the organized militia of this State as provided in
- 37 this article and the [National Defense Act and] regulations [made in pursuance
- 38 thereof GOVERNING THE ARMED FORCES OF THE UNITED STATES.
- 39 [It shall be unlawful for any person to misstate his age for the purpose of
- 40 securing enlistment in the organized militia of this State. It shall be unlawful for any
- 41 person to enlist in two military organizations at the same time. Any person violating
- 42 provisions of this section shall be guilty of fraudulent enlistment.]

- 2 Each company, troop, battery, detachment and unit in the organized militia shall
- 3 assemble for drill and instruction, including indoor target practice, not less than
- 4 forty-eight times each year, and shall, in addition thereto, participate in
- 5 encampments, maneuvers or other exercises, including outdoor target practice, at
- 6 least fifteen days in training each year, unless such company, troop, battery,
- 7 detachment and unit shall have been excused from participation in any part thereof
- 8 by the Governor; provided that credit for an assembly for drill or for indoor target
- 9 practice shall not be given unless the number of officers and enlisted men present for
- 10 duty at such assembly shall equal or exceed a minimum to be prescribed by the
- 11 Governor, nor unless the period of actual military duty and instruction participated in
- 12 by each officer and enlisted man at each such assembly at which he shall be credited
- 13 as having been present shall be of at least one and one-half hours' duration and the
- 14 character of training such as may be prescribed by the Governor.]

- All arms, equipment and other property furnished to organizations of this State
- 17 shall, when required by the Adjutant General, or a commanding officer of any such
- 18 organization be deposited in the armory of the said organization, and failure to
- 19 deposit as aforesaid any article of such property by the person to whom it was issued,
- 20 ten days after he shall have been notified, by written notice from the commanding
- 21 officer, as aforesaid, to return to the armory, shall be considered as a misdemeanor,

- 30 Every officer and enlisted man to whom public property of the State or United
- 31 States has been issued shall be personally responsible to the State for such property,
- 32 and no one shall be relieved from such responsibility except it be shown to the
- 33 satisfaction of the Governor that the loss or destruction of such property was
- 34 unavoidable and in no way the fault of the person responsible for the same; in all
- 35 other cases the value of the property lost or destroyed shall be charged against the
- 36 person at fault or the organization to which it had been issued; and such person or
- 37 organization, if not relieved from such charge by the Governor, shall pay the value of
- 38 such property to the Adjutant General within ninety days after such loss or
- 39 destruction. The value of the lost or destroyed property and the persons or
- 40 organizations to be charged therewith shall be determined by an inspector appointed
- 41 by the Adjutant General. In cases of disagreement, such value shall be fixed by the
- 42 Adjutant General.]

- 2 At any time upon the report and recommendation of the Adjutant General to the
- 3 effect that an organization is not up to the proper standard of numbers, efficiency or
- 4 discipline required, the Governor may, in his discretion, muster out of service such
- 5 organization so reported inefficient, and thereupon the commissions of all the officers
- 6 of such company or separate organization shall be vacated; provided, no organization
- 7 of the National Guard, members of which shall be entitled to and have received
- 8 compensation under the National Defense Act, shall be disbanded without the
- 9 consent of the President.]

- 11 (a) The provisions of this section shall apply when the organized militia, or
- 12 any part thereof, shall be ordered out for active duty or training by the Governor, or
- 13 by his authority; but shall not apply to the organized militia or any part thereof,
- 14 which has been ordered to duty incident to a call or order into the active military
- 15 service of the United States.
- 16 (b) Officers, warrant officers, and enlisted [men] PERSONS shall receive the
- 17 same per diem pay, including longevity pay, subsistence and allowances, as officers,
- 18 warrant officers and enlisted [men] PERSONS of the regular Army of like grade and
- 19 length of service, but no such persons ordered to active duty other than for training
- 20 shall be paid a per diem of less than 12 times the hourly federal minimum wage in
- 21 effect at the time of active duty.
- 22 [(c) Each enlisted man who has served a full three-year term of enlistment
- 23 and who reenlists within ninety days after the expiration of his previous enlistment,
- 24 shall receive an increase of 10 percent of his pay during this enlistment, and for each
- 25 three years of enlistment served thereafter an increase of 10 percent shall be granted;
- 26 not to exceed forty percent.]
- 27 [(d)] (C) Each enlisted [man] PERSON who qualifies as prescribed by the
- 28 Governor, in small arms practice or as proficient in the various duties of the branch or
- 29 arm to which [he] THE PERSON belongs, shall be paid the following increase in pay of
- 30 [his] THE PERSON'S respective grade for a period of [one] 1 year beginning on
- 31 January [first] 1 following such qualification: experts, 20 percent; sharpshooters,
- 32 gunners, drivers, and medical, first class, 15 percent; marksmen, gunners, drivers,
- 33 and medical, second class, 10 percent.
- 34 [(e) Officers, warrant officers and enlisted men of the organized militia, who
- 35 entered the military or naval service of the United States in the Spanish-American,
- 36 World War I, or subsequent wars or emergencies, shall be entitled to credit for the
- 37 time served in such federal status as if the service had been rendered in the organized
- 38 militia.]
- 39 [34.
- 40 The separate organizations in the City of Baltimore known as the Veteran Corps
- 41 of the Fifth Regiment, Infantry, M.N.G., and Old Guard, M.N.G., respectively, shall be

- 1 entitled to all rights and privileges conferred by this article except that said
- 2 organizations shall not be entitled to the privileges of retirement or to be placed on
- 3 reserve list nor to wear a uniform not distinctive from the active military forces of the
- 4 State; nor to share any appropriation made for the support of the militia other than
- 5 for the payment of rent, light and heat, upon approval of the Adjutant General, unless
- 6 said organizations are called for service by the Governor in case of emergency to aid
- 7 the organized militia in quelling insurrection, invasion, riot or breach of peace; when
- 8 so called upon the members of said organizations shall first sign, execute and deliver
- 9 through their commanding officers to the officer commanding the units of the
- 10 organized militia to whom ordered to report, a form of enlistment to be prescribed by
- 11 the Governor, for a term not to exceed ninety days at one time, and if the services of
- 12 such organizations shall not be required for the full term of their enlistment they
- 13 shall be discharged by the Governor. If called into the service of the State, the
- 14 members of said organizations shall be equipped and paid by the State and shall,
- 15 insofar as applicable, be considered a part of the organized militia of the State.]

- 17 (A) No body of [men] PERSONS other than the units of the organized militia 18 and the troops of the United States[, except such military organizations as are now in
- 19 existence,] shall associate themselves together as a military company or organization
- 20 or parade in public as a military company or organization without the permission of
- 21 the Governor.
- 22 (B) No armed military force from another state, territory or district shall be
- 23 permitted to enter the State for the purpose of doing military duty therein, without
- 24 the permission of the Governor; provided, that the provisions of this section shall not
- 25 apply to troops acting under the authority of the President.
- 26 36.
- 27 The Governor may, upon the recommendation of [their commanding officers,
- 28 approved by] the Adjutant General, confer brevet commissions upon officers of the
- 29 organized militia of a grade next higher than the regular commission held by them.
- 30 The Governor may also confer upon officers of the organized militia, brevet
- 31 commissions of a grade equal to the highest grade in which they previously served in
- 32 the organized militia, or in the Army of the United States. Brevet commissions shall
- 33 carry with them only such privileges or rights as are allowed in like cases in the
- 34 military service of the United States.

- 36 In order to reward those citizens of Maryland who volunteered in the
- 37 Spanish-American War, or who served in any subsequent war, or who served in the
- 38 Korean conflict between June 25, 1950 and July 27, 1953, or the Vietnam conflict, the
- 39 Governor shall have power, under regulations to be prescribed by him, to issue medals
- 40 of appropriate designs, to officers and enlisted personnel who served in any of the
- 41 various branches of the armed forces of the United States.]

- 2 In recognition of the services rendered by those citizens of Maryland who served
- 3 in the various branches of the armed forces of the United States in World War II, or
