- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 12

1 Article 2B - Alcoholic Beverages 2 8-224. 3 THIS SECTION APPLIES ONLY IN WORCESTER COUNTY. (A) THERE IS A CLASS I BEER, WINE AND LIQUOR LICENSE. 4 (B) 5 A CLASS I BEER, WINE AND LIQUOR LICENSE MAY BE ISSUED ONLY (C) 6 WITHIN: 7 THE CORPORATE LIMITS OF OCEAN CITY; (1) 8 (2) THE BOUNDARY LINES OF THE 10TH ELECTION DISTRICT; (3) THE BOUNDARY LINES OF THE 2ND PRECINCT OF THE 3RD ELECTION 10 DISTRICT: OR THE AREA BOUNDED BY MARYLAND ROUTE 589 TO THE NORTH AND 11 12 EAST, U.S. ROUTE 50 TO THE SOUTH, AND U.S. ROUTE 113 TO THE WEST, ALL OF 13 WHICH LIE WITHIN THE 1ST PRECINCT OF THE 3RD ELECTION DISTRICT. 14 THE ANNUAL LICENSE FEE FOR THE 6-DAY LICENSE IS \$3,000 \$2,500. (D) (1) THE ANNUAL LICENSE FEE FOR THE 7-DAY LICENSE IS \$3,500 \$3,000. 15 (2) A LICENSEE MAY SELL BEER, WINE, AND LIQUOR FOR ON-PREMISES 16 (E) 17 CONSUMPTION ONLY. 18 (F) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, ALL 19 LICENSE FEES SHALL GO TO THE GENERAL FUNDS OF THE COUNTY. IF THE LICENSED PREMISES ARE IN A MUNICIPAL CORPORATION, 75 21 PERCENT OF THE FEES SHALL GO TO THAT MUNICIPAL CORPORATION. A LICENSEE SHALL PURCHASE ALL ALCOHOLIC BEVERAGES, EXCEPT 22 23 LIGHT WINE AND BEER, FROM THE LIQUOR CONTROL BOARD. A LICENSEE MAY PURCHASE BEER AND LIGHT WINE FROM A 24 (2)25 LICENSED WHOLESALER. EXCEPT AS PROVIDED IN PARAGRAPH (4) OF THIS SUBSECTION, A 26 (3)27 LICENSEE SHALL BE CHARGED 85 PERCENT OF THE RETAIL PRICE OR ANY SPECIAL 28 SALE PRICE OR DISCOUNT PRICE. WHICHEVER IS LOWER. SET BY THE LIOUOR 29 CONTROL BOARD FOR WINE AND LIQUOR.
