BE IT ENACTED BY THE GENERAL ASSEMBLY OF 17 18 MARYLAND, That the Laws of Maryland read as follows: 19 **Article - Transportation** 20 27-101. 21 Any person who is convicted of a violation of any of the provisions of the

22 following sections of this article is subject to a fine of not more than \$500 or

23 imprisonment for not more than 2 months or both:

- 9 (f) (1) Any person who is convicted of a violation of any of the provisions of
- 10 § 14-103 of this article ("Possession of motor vehicle master key"), or of a second or
- 11 subsequent violation of any of the provisions of § 16-101 of this article ("Drivers must
- 12 be licensed") or, except as provided in subsection (q) of this section, § 21-902(b) [of
- $13\;$  this article] ("Driving while under the influence of alcohol"),  $\S~21\mbox{-}902(C)$  ("DRIVING
- 14 WHILE UNDER THE INFLUENCE OF DRUGS OR DRUGS AND ALCOHOL"), OR § 21-902(D)
- 15 ("DRIVING WHILE UNDER THE INFLUENCE OF A CONTROLLED DANGEROUS

- 24 THE PURPOSE OF SECOND OR SUBSEQUENT OFFENDER PENALTIES FOR A

- 26 THIS SUBSECTION, A PRIOR CONVICTION OF § 21-902(A), (B), (C), OR (D) OF THIS
- 27 ARTICLE SHALL BE CONSIDERED A CONVICTION OF § 21-902(C) OF THIS ARTICLE.
- 28 (4) EXCEPT AS PROVIDED IN SUBSECTION (Q) OF THIS SECTION, FOR
- 29 THE PURPOSE OF SECOND OR SUBSEQUENT OFFENDER PENALTIES FOR A
- 30 VIOLATION OF § 21-902(D) OF THIS ARTICLE PROVIDED UNDER PARAGRAPH (1) OF
- 31 THIS SUBSECTION, A PRIOR CONVICTION OF § 21-902 (A), (B), (C), OR (D) SHALL BE
- 32 CONSIDERED A CONVICTION OF § 21-902(D) OF THIS ARTICLE.
- 33 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 34 October 1, 1999.
