12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

13 MARYLAND, That the Laws of Maryland read as follows:

Article 27 - Crimes and Punishments

16 (A) A PERSON MAY NOT, WITH THE INTENT THAT THE OFFENSE BE
17 COMMITTED, UTILIZE A COMPUTER OR ANY OTHER ELECTRONIC MEANS TO SOLICIT,
18 INDUCE, LURE, OR ENTICE A MINOR OR ANOTHER PERSON BELIEVED TO BE A MINOR
19 TO COMMIT OR JOIN IN THE COMMISSION OF THE OFFENSES OF:

20 (1) A SEXUAL OFFENSE IN VIOLATION OF § 462, § 463, § 464, § 464A, § 464B, 21 OR § 464C OF THIS ARTICLE;

22 (2) CHILD ABUSE UNDER § 35C OF THIS ARTICLE; OR

23(3)CHILD PORNOGRAPHY AS DEFINED UNDER §§ 419A AND 419B OF THIS24 ARTICLE.

25 (B) IT IS A DEFENSE TO A PROSECUTION UNDER THIS SECTION THAT THE

26 DEFENDANT, AFTER SOLICITING A MINOR TO COMMIT AN OFFENSE LISTED IN

27 SUBSECTION (A) OF THIS SECTION, PERSUADED THE MINOR NOT TO DO SO OR

1 OTHERWISE PREVENTED THE COMMISSION OF THE OFFENSE UNDER

4 (C) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A FELONY AND ON 5 CONVICTION IS SUBJECT TO THE MAXIMUM SENTENCE FOR THE CRIME SOLICITED.

6 (D) A COURT OF COMPETENT JURISDICTION IN THIS STATE MAY TRY A
7 PERSON WHO ALLEGEDLY VIOLATES ANY PROVISION OF THIS SECTION IN ANY
8 COUNTY IN THIS STATE WHERE:

9 (1) THE PERSON PERFORMS THE ACT;

10 (2) THE MINOR RESIDES; OR

11 (3) THE COMPUTER OR OTHER ELECTRONIC MEANS IS LOCATED.

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 13 October 1, 1999.
