4 FOR the purpose of permitting a clerk to receive and record certain copies of a

- 5 canceled check as a release of a mortgage or deed of trust; providing that under
- 6 certain circumstances a copy of a canceled check has the same effect as a release
- 7 on property for which a mortgage or deed of trust is a security; and generally
- 8 relating to the recordation of instruments showing a release of a mortgage or
- 9 deed of trust.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

16 MARYLAND, That the Laws of Maryland read as follows:

The canceled check OR COPY ACCOMPANIED BY 3 THE CERTIFICATE has the same effect as a release of the property for which the 4 mortgage or deed of trust is the security, as if a release were executed by the 5 mortgagee or named trustees, if: 6 The party making satisfaction of the mortgage or deed of trust (i) 7 has: Allowed at least a 60-day waiting period, from the date 8 1. 9 the mortgage or deed of trust is paid fully or is satisfied, for the party satisfied to 10 provide a release suitable for recording; 11 2. Sent the party satisfied a copy of this section and a notice 12 that, unless a release is provided within 30 days, the party making satisfaction will 13 obtain a release by utilizing the provisions of this paragraph; and 14 3. Following the mailing of the notice required under 15 sub-subparagraph 2. of this subparagraph, allowed an additional waiting period of at 16 least 30 days for the party satisfied to provide a release suitable for recording; and 17 The canceled check OR COPY ACCOMPANIED BY THE (ii) 18 CERTIFICATE contains the name of the party whose debt is being satisfied, the debt 19 account number, if any, and words indicating that the check is intended as payment in 20 full of the debt being satisfied; and 21 (iii) There is attached to the canceled check OR COPY ACCOMPANIED 22 BY THE CERTIFICATE an affidavit made by a member of the Maryland Bar that the 23 mortgage or deed of trust has been satisfied, that the notice required under 24 subparagraph (i) of this paragraph has been sent, and specifically setting forth the 25 land record reference where the original mortgage or deed of trust is recorded.

26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 27 October 1, 1999.
