A BILL ENTITLED

1 AN ACT concerning

2 **Academic Facilities Bonding Authority**

3 FOR the purpose of approving certain projects for the acquisition, development, and
4 improvement of certain academic facilities for the University System of
5 Maryland; and approving the issuance of bonds by the University System of
6 Maryland for financing the projects.

7 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
8 MARYLAND, That:

9 (1) In accordance with Title 19 of the Education Article, each of the following
10 projects is approved as a project for an academic facility, and the University System of
11 Maryland may issue, sell, and deliver bonds in the total principal amount of
12 \$12,205,000 for the purposes of financing and refinancing the costs of these projects:

13 (A) University of Maryland, Baltimore (Baltimore City)

14 (i) Construct Addition and Alterations to Law School and Marshall
15 Library

16 (B) University System of Maryland College Park (Prince George's
17 County)

18 (i) Renovate Hornbake/McKeldin Libraries

19 (ii) Renovate Taliaferro/Key Hall

20 (2) In accordance with Title 19 of the Education Article, each of the following
21 capital facilities renewal projects is hereby approved as a project for an academic
22 facility, and the University System of Maryland may issue, sell, and deliver bonds in
23 the principal amount of \$12,795,000 for the purposes of financing and refinancing the
24 costs of these projects:

16 (3) The bonds issued under the authority of this Act do not create or constitute
17 any indebtedness or obligation of the State or of any political subdivision thereof
18 except the University System of Maryland, and the bonds shall so state on their face.
19 The bonds do not constitute a debt or obligation contracted by the General Assembly
20 of Maryland or pledge the faith and credit of the State within the meaning of Article
21 III, Section 34 of the Constitution of Maryland.

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
23 July 1, 1999.
