## 2 Somerset County - Alcoholic Beverages - Retail Sale of Wine

- 3 FOR the purpose of adding Somerset County to provisions authorizing in specified
- 4 jurisdictions the issuance of a Class A light wine license for retail sale of wine;
- 5 authorizing certain wineries to provide wine samples to visitors in Somerset
- 6 County; establishing certain restrictions and limitations on wine samples
- 7 provided by a winery; and generally relating to the retail sale of wine in
- 8 Somerset County.

- 19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 20 MARYLAND, That the Laws of Maryland read as follows:

## 1 **Article 2B - Alcoholic Beverages** 2 4-201. 3 (a) A Class A light wine license may be issued only in: 4 (1) Baltimore County; 5 (2) Carroll County; 6 (3) Dorchester County; 7 (4) Frederick County; 8 (5) Garrett County; 9 (6) Harford County; 10 (7) Montgomery County; 11 (8) SOMERSET COUNTY; 12 Talbot County; and (9) 13 Washington County. [(9)](10)14 (b) (1) The annual fee for this license is \$50. 15 (2) In Montgomery County the annual license fee is \$100. 16 (3) In Garrett County, the issuing fee for this license is \$50. 17 A Class A light wine license may be issued by the license issuing authority 18 of the county in which the place of business is located to any holder of a Class 4 19 manufacturer's license. 20 The license authorizes the holder to keep for sale and to sell light (d) (1) 21 wines produced at the winery in any quantity to any consumer at retail at the place 22 described in the license. The light wine shall be delivered in a sealed package or 23 container which may not be opened or the contents consumed on the licensed 24 premises. 25 In Montgomery County the licensee may not make more than 20,000 (2) 26 gallons of on-premises sales per year. 27 (e) (1) This subsection applies only in the following counties: 28 (i) Baltimore County; 29 (ii) Frederick County; 30 (iii) Garrett County;

- Baltimore County wineries applying for a Class A/Class 3 license are 9 exempt from quotas established by the Baltimore County Liquor Board as to the

- 12 (A) IN SOMERSET COUNTY, THE HOLDER OF A CLASS 3 OR A CLASS 4 WINE
- 13 LICENSE MAY PROVIDE SAMPLES OF WINE TO PERSONS VISITING THE LICENSED
- 14 PREMISES.
- 15 THE WINE SAMPLING PRIVILEGE AUTHORIZES THE HOLDER TO SERVE A (B)
- 16 MAXIMUM OF 2 OUNCES OF WINE FROM EACH GIVEN BRAND THAT IS
- 17 MANUFACTURED ON THE PREMISES TO EACH PERSON FOR SAMPLING PURPOSES.
- 18 THE WINE SAMPLE SHALL BE SERVED AND CONSUMED ON THE PREMISES 19 WHERE THE WINE IS MANUFACTURED.
- 20 (D) THE HOLDER MAY NOT CHARGE FOR THE SAMPLING.
- 21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 22 October 1, 1999.
