2 Cemeteries - Renewal of Permits

- 3 FOR the purpose of authorizing the Office of Cemetery Oversight to renew permits
- 4 issued to certain persons who wish to operate cemeteries or sell burial goods;

- 16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 17 MARYLAND, That the Laws of Maryland read as follows:

1 **Article - Business Regulation** 2 5-101. 3 (a) In this title the following words have the meanings indicated. 4 "Permit" means a permit issued by the Director to allow a partnership, (i) 5 limited liability company, or corporation to operate a business through which a 6 registrant may engage in the operation of a cemetery or provide burial goods. "Registration" means a registration issued by the Director authorizing an 7 8 individual to operate a cemetery or to provide burial goods. 9 5-307. 10 (a) Unless a registration OR PERMIT is renewed as provided in this section, the 11 registration OR PERMIT expires on the second anniversary of its effective date. 12 At least 90 days before a [license] REGISTRATION OR PERMIT expires, the (b) 13 Director shall mail to the registrant OR PERMIT HOLDER, at the last known address of 14 the registrant OR PERMIT HOLDER: 15 a renewal application form; and (1) 16 (2) a notice that states: 17 (i) the date on which the current registration OR PERMIT expires; 18 the date by which the Director must receive the renewal (ii) 19 application for the renewal to be issued and mailed before the registration OR PERMIT 20 expires; and 21 (iii) the amount of the renewal fee. 22 Before a registration OR PERMIT expires, the registrant OR PERMIT 23 HOLDER periodically may renew it for an additional 2-year term, if the registrant OR 24 PERMIT HOLDER: is otherwise entitled to be registered OR TO RECEIVE A PERMIT; 25 (1) 26 (2) meets the qualifications set forth for an original registration OR 27 PERMIT; 28 (3) pays the renewal fee set by the Director; and 29 (4) submits to the Director a renewal application on the form that the 30 Director provides. The Director shall renew the registration OR PERMIT of each registrant OR

32 PERMIT HOLDER who meets the requirements of this section.

- 1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take 2 effect October 1, 1999.
