- 11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

- 15 (A) SUBJECT TO THE PROVISIONS OF THIS SECTION, THE BOARD MAY WAIVE
- 16 THE EXAMINATION REQUIREMENTS FOR A MASTER PLUMBER LICENSE OR A
- 17 JOURNEY PLUMBER LICENSE FOR AN INDIVIDUAL WHO IS LICENSED TO PROVIDE
- 18 PLUMBING SERVICES IN ANOTHER STATE ON THE AFFIRMATIVE VOTE OF AT LEAST A
- 19 MAJORITY OF THE AUTHORIZED MEMBERSHIP OF THE BOARD.

SENATE BILL 50

- 1 (B) THE BOARD MAY GRANT A WAIVER UNDER THIS SECTION ONLY IF AN 2 APPLICANT:
- 3 (1) PAYS THE APPROPRIATE FEE REQUIRED UNDER § 12-306 OF THIS 4 SUBTITLE; AND
- 5 (2) PROVIDES ADEQUATE EVIDENCE THAT THE APPLICANT:
- 6 (I) MEETS THE QUALIFICATIONS OTHERWISE REQUIRED BY THIS 7 TITLE:
- 8 (II) HOLDS AN ACTIVE LICENSE IN GOOD STANDING IN THE OTHER 9 STATE;
- 10 (III) HOLDS A LICENSE THAT IS EQUIVALENT TO THE STATE 11 LICENSE; AND
- 12 (IV) BECAME LICENSED IN THE OTHER STATE AFTER MEETING
- 13 REQUIREMENTS THAT ARE AT LEAST EQUIVALENT TO THE LICENSING
- 14 REQUIREMENTS OF THIS STATE.
- 15 (C) THE BOARD MAY GRANT A WAIVER ONLY IF THE STATE IN WHICH THE
- 16 APPLICANT IS LICENSED WAIVES THE EXAMINATION OF LICENSEES OF THIS STATE
- 17 TO A SIMILAR EXTENT AS THIS STATE WAIVES THE EXAMINATION REQUIREMENTS
- 18 FOR INDIVIDUALS LICENSED IN THAT STATE.
- 19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 20 October 1, 1999.
