1 AN ACT concerning
2 Prospective Jurors - Motor Vehicle Administration Lists
3 FOR the purpose of expanding the sources from which prospective jurors shall be
4 selected by the jury commissioner or clerk of the court to include lists of certain
5 individuals who have been issued a driver's license or an identification card by
6 the Motor Vehicle Administration; requiring the Administration to make
7 available to the jury commissioners or clerks certain lists without cost; making
8 stylistic changes; providing for a delayed effective date; and generally relating to
9 the selection of prospective jurors.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
16 MARYLAND, That the Laws of Maryland read as follows:
17 Article - Courts and Judicial Proceedings
18 8-104.
19 (A) The jury commissioner or the clerk of the court shall select the names of
20 prospective jurors from among:
21 (1) [those] THOSE persons AT LEAST 18 years old [or older] whose
22 names appear on the voter registration lists[,];

- 1 (2) THE LIST OF INDIVIDUALS AT LEAST 18 YEARS OLD WHO HAVE BEEN 2 ISSUED A DRIVER'S LICENSE BY THE MOTOR VEHICLE ADMINISTRATION;
- 3 (3) THE LIST OF INDIVIDUALS AT LEAST 18 YEARS OLD WHO HAVE BEEN 4 ISSUED AN IDENTIFICATION CARD BY THE MOTOR VEHICLE ADMINISTRATION; and
- 5 (4) [from such additional] ADDITIONAL sources permitted by a plan 6 adopted under § 8-201 OF THIS TITLE.
- 7 (B) Volunteers for jury service shall be refused, and recommendations, if made, 8 may not be accepted.

- 10 (A) Any State or local official who has custody, possession, or control of voter
- 11 registration lists shall make the lists and records available to the jury commissioner
- 12 or clerks for inspection and copying at any reasonable time.
- 13 (B) (1) THE MOTOR VEHICLE ADMINISTRATION SHALL MAKE AVAILABLE TO
- 14 THE JURY COMMISSIONER OR CLERKS FOR INSPECTION AND COPYING AT ANY
- 15 REASONABLE TIME:
- 16 (I) THE LIST OF INDIVIDUALS WHO ARE AT LEAST 18 YEARS OLD
- 17 AND HAVE BEEN ISSUED A DRIVER'S LICENSE BY THE MOTOR VEHICLE
- 18 ADMINISTRATION: AND
- 19 (II) THE LIST OF INDIVIDUALS WHO ARE AT LEAST 18 YEARS OLD
- 20 AND HAVE BEEN ISSUED AN IDENTIFICATION CARD BY THE MOTOR VEHICLE
- 21 ADMINISTRATION.
- 22 (2) THE LISTS DESCRIBED IN THIS SUBSECTION SHALL BE PROVIDED BY
- 23 THE MOTOR VEHICLE ADMINISTRATION TO THE JURY COMMISSIONER OR CLERKS
- 24 WITHOUT COST.
- 25 (C) The circuit court of a county upon application by the Attorney General,
- 26 may compel compliance with this section.
- 27 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take
- 28 effect January 1, 2000.
