## 2 State Comptroller's Office - Investigative Services Unit

- 3 FOR the purpose of providing that employees of the Investigative Services Unit of the
- 4 State Comptroller's Office who are sworn police officers shall be subject to the
- same salary plan, including grades, steps, and increments based on length of
- 6 service, as Maryland State Police officers; providing that employees of the
- 7 Investigative Services Unit who are sworn police officers shall receive certain
- 8 salary, grade, and step increases under certain circumstances; providing that an
- 9 employee of the Investigative Services Unit who is a sworn police officer shall
- 10 receive credit for years of creditable service under the Law Enforcement
- Officers' Pension System in determining the employee's length of service;
- requiring the reestablishment of a certain pay scale parity between Maryland
- 13 State Police officers and sworn police officers of the Investigative Services Unit;
- and generally relating to the salaries of certain employees of the Investigative
- 15 Services Unit of the State Comptroller's Office.

- 21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 22 MARYLAND, That the Laws of Maryland read as follows:
- 23 Article Tax General
- 24 2-107.1.
- 25 (A) EMPLOYEES OF THE INVESTIGATIVE SERVICES UNIT OF THE
- 26 COMPTROLLER'S OFFICE WHO ARE SWORN POLICE OFFICERS SHALL BE SUBJECT TO
- 27 THE SAME SALARY PLAN, INCLUDING GRADES, STEPS, AND INCREMENTS BASED ON
- 28 LENGTH OF SERVICE, AS MARYLAND STATE POLICE OFFICERS.

- 1 (B) WHENEVER MARYLAND STATE POLICE OFFICERS RECEIVE A SALARY
- 2 INCREASE, EMPLOYEES OF THE INVESTIGATIVE SERVICES UNIT WHO ARE SWORN
- 3 POLICE OFFICERS SHALL RECEIVE A SALARY INCREASE IN THE SAME PERCENTAGE
- 4 AS THE SALARY INCREASE RECEIVED BY MARYLAND STATE POLICE OFFICERS.
- 5 (C) WHENEVER MARYLAND STATE POLICE OFFICERS RECEIVE A GRADE OR
- 6 STEP INCREASE, EMPLOYEES OF THE INVESTIGATIVE SERVICES UNIT WHO ARE
- 7 SWORN POLICE OFFICERS SHALL RECEIVE AN EQUAL GRADE OR STEP INCREASE.
- 8 (D) IN DETERMINING LENGTH OF SERVICE OF AN EMPLOYEE OF THE
- 9 INVESTIGATIVE SERVICES UNIT WHO IS A SWORN POLICE OFFICER, THE EMPLOYEE
- 10 SHALL BE GIVEN CREDIT FOR YEARS OF CREDITABLE SERVICE UNDER THE LAW
- 11 ENFORCEMENT OFFICERS' PENSION SYSTEM.
- 12 SECTION 2. AND BE IT FURTHER ENACTED, That the pay scale parity that
- 13 existed between Maryland State Police officers and sworn police officers of the
- 14 Investigative Services Unit of the State Comptroller's Office on June 30, 1997, shall
- 15 be reestablished by adjusting the salary scale of the sworn police officers of the
- 16 Investigative Services Unit to match certain comparable ranks of Maryland State
- 17 Police officers. For purposes of this Act, comparable ranks between the sworn police
- 18 officers of the Investigative Services Unit and Maryland State Police officers are as
- 19 follows:
- 20 (1) Agent I is comparable to Maryland State Police Trooper;
- 21 (2) Agent II is comparable to Maryland State Police Trooper First Class; and
- 22 (3) Agent III is comparable to Maryland State Police Corporal.
- 23 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 24 July 1, 1999.
