2 Public Right to Know - Air Quality Health Disclosure Information

- 3 FOR the purpose of requiring the Department of the Environment, on and after a
- 4 certain date, to provide the public with access to all ambient air monitoring data
- 5 through the Internet; authorizing certain data to be provided in a certain form
- 6 and requiring that the data include, at a minimum, all validated air monitoring
- data obtained during the current and previous calendar year; defining a certain
- 8 term; and generally relating to public access to certain ambient air monitoring
- 9 data.

- 20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 21 MARYLAND, That the Laws of Maryland read as follows:

- 24 (a) In this article the following words have the meanings indicated.
- 25 (d) "Department" means the Department of the Environment.

- 2 (A) IN THIS SECTION, "AMBIENT AIR MONITORING DATA" MEANS MEASURED
- 3 CONCENTRATIONS OF AIR POLLUTANTS, INCLUDING AIR POLLUTANTS FOR WHICH
- 4 THERE ARE NO AMBIENT AIR QUALITY STANDARDS, OBTAINED FROM ANY AMBIENT
- 5 AIR MONITORING STATION ESTABLISHED BY THE DEPARTMENT.
- 6 (B) ON AND AFTER JANUARY 1, 2000, THE DEPARTMENT SHALL PROVIDE 7 PUBLIC ACCESS TO ALL AMBIENT AIR MONITORING DATA THROUGH THE INTERNET.
- 8 (C) AMBIENT AIR MONITORING DATA THE DEPARTMENT PROVIDES IN
- 9 ACCORDANCE WITH SUBSECTION (B) OF THIS SECTION MAY BE IN SUMMARY FORM
- 10 AND SHALL INCLUDE, AT A MINIMUM, ALL VALIDATED AMBIENT AIR MONITORING
- 11 DATA THE DEPARTMENT OBTAINS DURING EACH CURRENT AND PREVIOUS
- 12 CALENDAR YEAR.
- 13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 14 October 1, 1999.
