1 AN ACT concerning

2 Continuity of Patient Care Act

- 3 FOR the purpose of requiring a health maintenance organization, under certain
- 4 circumstances, to reimburse a physician in an urgent care facility who provides
- 5 certain medically necessary follow-up care to a member or subscriber of the
- 6 health maintenance organization; prohibiting a health maintenance
- 7 organization, under certain circumstances, from imposing on a member or
- 8 subscriber any co-payment or other cost-sharing requirement that exceeds
- 9 what the member or subscriber is required to pay for services rendered by a
- physician who is a member of the provider panel of the health maintenance
- organization; and generally relating to health maintenance organizations.

- 17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 18 MARYLAND, That the Laws of Maryland read as follows:

- 21 IF A HEALTH MAINTENANCE ORGANIZATION AUTHORIZES, DIRECTS, REFERS,
- 22 OR OTHERWISE ALLOWS A MEMBER OR SUBSCRIBER OF THE HEALTH MAINTENANCE
- 23 ORGANIZATION TO USE A MEDICAL FACILITY THAT PROVIDES IMMEDIATE URGENT
- 24 CARE SERVICES FOR A CONDITION THAT READILY NECESSITATES A SURGICAL
- 25 PROCEDURE, THE HEALTH MAINTENANCE ORGANIZATION:
- 26 (1) SHALL REIMBURSE A PHYSICIAN IN THE URGENT CARE FACILITY
- 27 FOR PROVIDING ANY MEDICALLY NECESSARY FOLLOW-UP CARE RELATED TO THE
- 28 CONDITION FOR WHICH THE SURGICAL PROCEDURE WAS PERFORMED; AND

- 1 (2) MAY NOT IMPOSE ON THE MEMBER OR SUBSCRIBER ANY
- 2 CO-PAYMENT OR OTHER COST-SHARING REQUIREMENT THAT EXCEEDS WHAT THE
- 3 MEMBER OR SUBSCRIBER IS REQUIRED TO PAY FOR SERVICES RENDERED BY A
- 4 PHYSICIAN WHO IS A MEMBER OF THE PROVIDER PANEL OF THE HEALTH
- 5 MAINTENANCE ORGANIZATION.
- 6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 7 October 1, 1999.
