CHAPTER _____

1 AN ACT concerning

2 **Home Health Agencies - Authority of Secretary of Health and Mental**
3 **Hygiene - Repeal of Termination Date**

4 FOR the purpose of repealing a certain termination date concerning certain
5 regulatory authority of the Department of Health and Mental Hygiene
6 concerning home health agencies; and generally relating to the continuation of
7 certain regulatory authority concerning home health agencies.

8 BY repealing and reenacting, without amendments,

14 Chapter 432 of the Acts of the General Assembly of 1994
15 Section 3

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
17 MARYLAND, That the Laws of Maryland read as follows:

Article - Health - General

2 19-404.

3 (a) The Department shall adopt rules and regulations that set standards for
4 the care, treatment, health, safety, welfare, and comfort of patients of home health
5 agencies.

6 (b) The rules and regulations shall provide for the licensing of home health
7 agencies and annual license renewal, and shall establish standards that require as a
8 minimum, that all home health agencies:

9 (1) Within 10 days of acceptance of a patient for skilled care, make and
10 record all reasonable efforts to contact a physician to obtain the signed order required
11 under paragraph (2);

12 (2) That accept patients for skilled care do so only on the signed order of
13 a physician obtained within 28 days after acceptance;

14 (3) Adopt procedures for the administration of drugs and biologicals;

15 (4) Maintain clinical records on all patients accepted for skilled care;

16 (5) Establish patient care policies and personnel policies;

17 (6) Have services available at least 8 hours a day, 5 days a week, and
18 available on an emergency basis 24 hours a day, 7 days a week;

19 (7) Make service available to an individual in need within 24 hours of a
20 referral when stipulated by a physician's order;

21 (8) Have a designated supervisor of patient care who is a full-time
22 employee of the agency and is available at all times during operating hours and
23 additionally as needed; and

24 (9) Have as the administrator of the agency a person who has at least 1
25 year of supervisory experience in hospital management, home health management, or
26 public health program management and who is:

27 (i) A licensed physician;

28 (ii) A registered nurse; or

29 (iii) A college graduate with a bachelor's degree in a health-related
30 field.

31 (c) The rules and regulations may include provisions that:

32 (1) Deal with the establishment of home health agencies;

- 1 (2) Require each home health agency to have its policies established by a
2 professional group that includes at least:
- 3 (i) 1 physician;
- 4 (ii) 1 registered nurse;
- 5 (iii) 1 representative of another offered service; and
- 6 (iv) 1 public member;
- 7 (3) Govern the services provided by the home health agencies;
- 8 (4) Require keeping clinical records of each patient, including the plan of
9 treatment to be provided;
- 10 (5) Govern supervision of the services, as appropriate, by:
- 11 (i) A physician;
- 12 (ii) A registered nurse; or
- 13 (iii) Another health professional who is qualified sufficiently by
14 advanced training to supervise the same kind of services in a hospital; and
- 15 (6) Require submission of an annual report which includes service
16 utilization statistics.
- 17 (d) (1) A home health agency accredited by an organization approved by the
18 Secretary shall be deemed to meet State licensing regulations.
- 19 (2) (i) The home health agency shall submit the report of the
20 accreditation organization to the Secretary within 30 days of its receipt.
- 21 (ii) All reports submitted under this paragraph shall be available
22 for public inspection.
- 23 (3) The Secretary may:
- 24 (i) Inspect the home health agency for the purpose of a complaint
25 investigation;
- 26 (ii) Inspect the home health agency to follow up on a serious
27 problem identified in an accreditation organization's report; and
- 28 (iii) Annually, conduct a survey of up to 5 percent of all home health
29 agencies in the State to validate the findings of an accreditation organization's report.
- 30 (e) The provisions of this section do not waive the requirement for a home
31 health agency to obtain a certificate of need.

1 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland
2 read as follows:

4 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
5 October 1, 1994. [It shall remain effective for a period of 5 years and, at the end of
6 September 30, 1999, with no further action required by the General Assembly, this
7 Act shall be abrogated and of no further force and effect.]

9 October 1, 1999.
