- 3 FOR the purpose of authorizing a special wine festival licensee in Baltimore County
- 4 to display and sell certain beer under certain terms and conditions; requiring a
- 5 special beer and wine festival licensee to hold a requisite alcoholic beverages
- 6 license; and generally relating to special beer and wine festivals in Baltimore

- 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 14 MARYLAND, That the Laws of Maryland read as follows:

15 Article 2B - Alcoholic Beverages

16 8-303.

- 17 (a) The Baltimore County Board of License Commissioners may issue a 18 special BEER AND wine festival [(WF)] license.
- 19 (b) Notwithstanding any other provision to the contrary, an applicant for a
- 20 special [WF] BEER AND WINE FESTIVAL license shall be a holder of [an] A
- 21 REQUISITE existing retail alcoholic beverages license issued in the State [and
- 22 authorized under the license to sell wine], CLASS 7 MICRO-BREWERY LICENSE, State
- 23 Class 3 winery license, or State Class 4 winery license issued pursuant to this article.
- 24 (c) A special [WF] BEER AND WINE FESTIVAL licensee shall only display and
- 25 sell:
- 26 (1) [wine] WINE that is produced and processed in Maryland; AND

- 1 (2) BEER THAT IS PRODUCED AND PROCESSED AT A CLASS 7 2 MICRO-BREWERY IN MARYLAND.
- ${\it 3} \qquad {\it (d)} \qquad {\it A special [WF] BEER AND WINE FESTIVAL license entitles the holder to} \\$
- 4 display and sell at retail BEER AND wine for consumption on or off the licensed
- 5 premises on the days and for the hours designated for the SPECIAL BEER AND wine
- 6 festival in Baltimore County.
- 7 (e) The license fee is \$15.
- 8 (f) The provisions of this section may not prohibit the licensee from holding 9 another alcoholic beverages license of a different class or nature.
- 10 (g) The Baltimore County Board of License Commissioners:
- 11 (1) Except for the dates chosen for the Cumberland and Shenandoah
- 12 Valley Wine Festival in Washington County, the Maryland Wine Festival in Carroll
- 13 County and the Anne Arundel County Beer and Wine Festival shall approve one
- 14 weekend annually for the SPECIAL BEER AND wine festival; and
- 15 (2) Shall approve a location in Baltimore County for this festival which 16 does not hold an alcoholic beverages license.
- 17 (h) The Baltimore County Board of License Commissioners shall adopt 18 regulations for implementing this section.
- 19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 20 June 1, 1999.
