# 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

14 MARYLAND, That the Laws of Maryland read as follows:

# Article 2B - Alcoholic Beverages

16 8-303.

17 (a) The Baltimore County Board of License Commissioners may issue a 18 special BEER AND wine festival [(WF)] license.

19 (b) Notwithstanding any other provision to the contrary, an applicant for a

20 special [WF] BEER AND WINE FESTIVAL license shall be a holder of [an] A

21 REQUISITE existing retail alcoholic beverages license issued in the State [and

1 authorized under the license to sell wine], CLASS <u>5 BREWERY LICENSE, CLASS</u> 7

2 MICRO-BREWERY LICENSE, State Class 3 winery license, or State Class 4 winery 3 license issued pursuant to this article.

4 (c) A special [WF] BEER AND WINE FESTIVAL licensee shall only display and 5 sell:

6 (1) [wine] WINE that is produced and processed in Maryland; AND

7 (2) BEER THAT IS PRODUCED AND PROCESSED AT <u>A CLASS 5 BREWERY</u>
8 <u>OR</u> A CLASS 7 MICRO-BREWERY IN MARYLAND.

9 (d) A special [WF] BEER AND WINE FESTIVAL license entitles the holder to 10 display and sell at retail BEER AND wine for consumption on or off the licensed 11 premises on the days and for the hours designated for the SPECIAL BEER AND wine 12 festival in Baltimore County.

13 (e) The license fee is \$15.

14 (f) The provisions of this section may not prohibit the licensee from holding 15 another alcoholic beverages license of a different class or nature.

16 (g) The Baltimore County Board of License Commissioners:

17 (1) Except for the dates chosen for the Cumberland and Shenandoah
18 Valley Wine Festival in Washington County, the Maryland Wine Festival in Carroll

19 County and the Anne Arundel County Beer and Wine Festival shall approve one

20 weekend annually for the SPECIAL BEER AND wine festival; and

21 (2) Shall approve a location in Baltimore County for this festival which 22 does not hold an alcoholic beverages license.

23 (h) The Baltimore County Board of License Commissioners shall adopt24 regulations for implementing this section.

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 26 June 1, 1999.
