Wavs and Means

State Aid for Public Education - School Operating Support Grants

This bill establishes a school operating support grant program for local boards of education. As a condition to receive the State grants, each local board is required to provide a local match. In addition, four local boards receive a special hold harmless grant.

This bill takes effect July 1, 1999 and sunsets June 30, 2002.

Fiscal Summary

State Effect: General fund expenditures increase by \$20.9 million in FY 2000. Future year expenditures remain relatively constant until the bill sunsets in FY 2002. Revenues would not be affected.

Local Effect: State aid to local governments increases by \$20.9 million in FY 2000. Local government expenditures increase by \$14.4 million in FY 2000 due to the local matching requirement.

Small Business Effect: None.

State Effect: This bill establishes a new education funding program for local school systems. In addition, it provides a special hold harmless grant to local school systems receiving less State aid under the basic current expense formula in fiscal 2000 than they received in the prior year. This additional funding would total \$708,000 in fiscal 2000. In sum, this bill would provide local school systems with an additional \$20.9 million in fiscal 2000. **Exhibit 1** provides a county-by-county distribution for fiscal 2000.

School Operating Support Grants

The school operating support grant program is modeled after the basic current expense formula, which is the major State aid program for primary and secondary education. The School Operating Support program in fiscal 2000 is based on a \$51 per pupil foundation that is shared by the State and counties. Each county's share is based on its full-time equivalent enrollment and county wealth. The State share totals \$25.50 per full-time equivalent student. The per pupil foundation amount increases to \$63 in fiscal 2001 and \$75 in fiscal 2002. The program terminates after fiscal 2002. The table below shows the projected State fiscal impact for fiscal 2000 through fiscal 2002.

Hold Harmless Grants

State aid under the basic current expense formula will increase by over \$48.9 million in fiscal 2000, representing a 3% increase from the prior year. However, 4 local school systems (Allegany, Garrett, Somerset, and Talbot Counties) will experience a decrease in State funding under this program in fiscal 2000. For example, in Allegany County, the funding decrease represents around 2% of the county's basic current expense aid or roughly \$53 per pupil. To hold these counties harmless from the funding decrease, this bill provides these counties with a special grant totaling \$708,000. The grant allocation is set forth below.

Local Effect: In order to receive the State school operating support grant, counties must provide a local match as determined in the bill. In fiscal 2000, the local match would total \$14.4 million. The local match is in addition to county funds needed to satisfy the local maintenance of effort requirement under the basic current expense formula. However, the local match does not count towards maintenance of effort in subsequent years. Accordingly, county governments will have to provide local school systems with at least \$14.4 million in additional funding over the maintenance of effort requirement. In fiscal 1998, the latest year in which data is available, county governments provided local school systems with \$30 million in funding above the maintenance of effort requirement. However, 7 counties provided the local school system with either the minimum required amount or an increase of less than 1%. **Exhibit 2** shows the maintenance of effort level and the local appropriation to the boards of education for fiscal 1998.
