(St. Mary's County Delegation)

Appropriations

St. Mary's County - Public Facilities Bonds

This bill authorizes the St. Mary's County Commissioners to issue up to \$25 million in general obligation bonds for construction, improvements, or development of public facilities. The date of maturity cannot exceed 30 years.

The bill is effective June 1, 1999

Fiscal Summary

State Effect: None.

Local Effect: St. Mary's County would receive up to \$25 million in bond proceeds for capital projects. County debt service expenditures would increase by an estimated \$2.39 million annually.

Small Business Effect: Minimal.

Fiscal Analysis

Local Effect: St. Mary's County revenues could increase by up to \$25 million due to the bond proceeds. As of June 30, 1998, the county had \$59.0 million in outstanding debt. The county currently has an A+\A1 credit rating. The interest rate for A rated 15-year bonds is estimated at 4.90%. Assuming the county issues \$25 million in bonds, the county's annual debt service costs on these bonds would be \$2,392,300.
