AMENDMENT NO. 1

On page 1, in the sponsor line, strike "and Rzepkowski" and substitute "Rzepkowski, Brown, Busch, Donoghue, Fulton, Harrison, Love, and Moe"; in line 3, after "of" insert "prohibiting certain insurers, nonprofit health service plans, and health maintenance organizations from excluding certain benefits for in vitro fertilization under certain circumstances;"; in line 6, after "infertility;" insert "decreasing the duration of time for which certain individuals must have a history of infertility in order to be eligible for certain in vitro fertilization health insurance benefits; authorizing certain insurers, nonprofit health service plans, and health maintenance organizations to limit coverage for certain in vitro fertilization benefits; providing for the application of this Act;"; and after line 7, insert:

"BY adding to

Section 19-706(nn)

Annotated Code of Maryland

(1996 Replacement Volume and 1999 Supplement)".

AMENDMENT NO. 2

On page 1, after line 14, insert:

"Article - Health - General

19-706.

(NN) THE PROVISIONS OF § 15-810 OF THE INSURANCE ARTICLE APPLY TO HEALTH MAINTENANCE ORGANIZATIONS.";

and after line 17, insert:

- "(1) INSURERS AND NONPROFIT HEALTH SERVICE PLANS THAT PROVIDE HOSPITAL, MEDICAL, OR SURGICAL BENEFITS TO INDIVIDUALS OR GROUPS ON AN EXPENSE-INCURRED BASIS UNDER HEALTH INSURANCE POLICIES THAT ARE ISSUED OR DELIVERED IN THE STATE; AND
- (2) HEALTH MAINTENANCE ORGANIZATIONS THAT PROVIDE HOSPITAL, MEDICAL, OR SURGICAL BENEFITS TO INDIVIDUALS OR GROUPS UNDER CONTRACTS THAT ARE ISSUED OR DELIVERED IN THE STATE.".

On pages 1 and 2, strike in their entirety the lines beginning with line 18 on page 1 through line 6 on page 2, inclusive.

On page 2, in line 7, strike "A policy, contract, or certificate" and substitute "AN ENTITY"; strike beginning with "policyholder" in line 9 down through "holder," in line 10 and substitute "POLICYHOLDER OR SUBSCRIBER"; strike beginning with "policyholder" in line 10 down through "holder" in line 11, and substitute "POLICYHOLDER OR SUBSCRIBER"; in line 15, strike "policyholder, subscriber, or certificate holder," and substitute "POLICYHOLDER OR SUBSCRIBER"; in line 16, strike "policyholder, subscriber, or certificate holder" and substitute "POLICYHOLDER OR SUBSCRIBER"; and strike beginning with "policy" in line 30 down through "certificate" in line 31 and substitute "POLICY OR CONTRACT".

AMENDMENT NO. 3

On page 2, in line 19, strike "5" and substitute "2".

AMENDMENT NO. 4

On page 3, after line 2, insert:

"(D) AN ENTITY SUBJECT TO THIS SECTION MAY LIMIT COVERAGE OF THE BENEFITS REQUIRED UNDER THIS SECTION TO THREE IN VITRO FERTILIZATION ATTEMPTS PER LIVE BIRTH, NOT TO EXCEED A MAXIMUM LIFETIME BENEFIT OF \$100,000."

AMENDMENT NO. 5

On page 3, before line 3, insert:

"SECTION 2. AND BE IT FURTHER ENACTED, That this Act applies to all policies,
