AMENDMENT NO. 1

On page 1, in line 2, strike "Maryland"; in the same line, after "Unit" insert "<u>Pilot Program</u>"; in line 3, strike "the Maryland" and substitute "<u>a</u>"; in the same line, after "Unit" insert "<u>Pilot Program</u>"; in line 4, after "provide" insert "<u>grant</u>"; strike beginning with "for" in line 4 down through "for" in line 5 and substitute "<u>to the sheriff's office or police department in one or more counties for the creation of a separate domestic violence unit dedicated to</u>"; in line 6, strike the first comma and substitute "<u>and</u>"; in the same line, strike ", and peace orders"; strike beginning with "authorizing" in line 8 down through "requiring" in line 9 and substitute "<u>authorizing</u>"; in line 9, strike "a"; in the same line, strike "appropriation" and substitute "<u>appropriations</u>"; in line 11, after "Fund;" insert "<u>requiring the Fund to be invested and reinvested in a certain manner; requiring the Comptroller to pay out money from the Fund under certain circumstances; providing that the Fund is subject to a certain audit;"; in line 15, after "report;" insert "<u>providing for the termination of this Act;</u>"; in line 16, strike "Maryland"; and in the same line after "Unit" insert "<u>Pilot Program</u>".</u>

AMENDMENT NO. 2

On page 1, in line 26, strike "MARYLAND"; in line 27, after "UNIT" insert "<u>PILOT</u> <u>PROGRAM</u>"; in line 28, strike "MARYLAND"; in the same line, after "UNIT" insert "<u>PILOT</u> <u>PROGRAM</u>"; and after line 28, insert:

"(2) <u>THE PURPOSE OF THE FUND IS TO PROVIDE GRANT MONEY TO</u> <u>THE SHERIFF'S OFFICE OR POLICE DEPARTMENT IN ONE OR MORE COUNTIES FOR</u> <u>THE CREATION OF A SEPARATE DOMESTIC VIOLENCE UNIT DEDICATED TO:</u>

On page 2, in line 1, strike "(2)" and substitute " $(\underline{C})(\underline{1})$ "; in lines 3, 7, 12, 14, 16, and 19, strike "(3)", "(4)", "(5)", "(6)", "(7)", and "(8)", respectively, and substitute " $(\underline{2})$ ", " $(\underline{3})$ ", " $(\underline{4})$ ", " $(\underline{4})$ ", " $(\underline{5})$ ", " $(\underline{6})$ ", and " $(\underline{7})$ ", respectively; in line 10, strike "SHALL" and substitute "<u>MAY</u>"; in line 11, strike "EACH"; and in the same line, strike "THEREAFTER" and substitute "<u>2002</u>".

On pages 2 and 3, strike in their entirety the lines beginning with line 21 on page 2 through line 3 on page 3, inclusive.

On page 3, in line 4, strike "(E)" and substitute "(D)"; in line 8, strike "OF EACH YEAR" and substitute "<u>2001</u>, AND OCTOBER 1, 2002"; strike beginning with "THAT" in line 11 down through "YEAR" in line 12 and substitute "<u>ON THE IMPACT OF THE FUND ON:</u>

<u>1.</u> <u>THE SERVICE OF EX PARTE ORDERS AND</u> <u>PROTECTIVE ORDERS ISSUED UNDER TITLE 4, SUBTITLE 5 OF THE FAMILY LAW</u> <u>ARTICLE; AND</u>

2. THE DATA ENTRY AND DATA UPDATING OF THOSE

in line 15, strike the first comma and substitute "<u>AND</u>"; in the same line, strike ", AND PEACE ORDERS," and substitute "<u>ISSUED UNDER TITLE 4, SUBTITLE 5 OF THE FAMILY LAW</u>

<u>ARTICLE</u>"; and in line 23, after "enacted." insert "<u>It shall remain effective through June 30, 2002,</u> and, at the end of June 30, 2002, with no further action required by the General Assembly, this Act shall be abrogated and of no further force and effect.".
