AMENDMENT NO. 3

On page 8, in line 12 strike "(G)" and substitute "(E)"; after line 13 insert:

"(F) <u>A MEMBER OF THE COMMISSION MAY NOT RECEIVE COMPENSATION</u> <u>BUT IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER STANDARD STATE</u> <u>TRAVEL REGULATIONS, AS PROVIDED IN THE STATE BUDGET.</u>"; and in line 14, strike "(H)" and substitute "(G)".
