AMENDMENTS TO SENATE BILL NO. 761

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, strike beginning with "Findings" in line 2 down through "Notice" in line 3 and substitute "Disclosure of Information"; in line 4, after "provide" insert "certain"; in line 5, strike "an entity or" and substitute "(a)"; strike beginning with the first "or" in line 6 down through "provisions" in line 7 and substitute "under certain circumstances; requiring the Secretary to provide certain written notice to certain persons on request under certain circumstances"; in line 8, in each instance, before "notice" insert "required written"; in line 10, strike "the statutory provision" and substitute "certain laws"; in line 11, after "Secretary," insert "requiring the Secretary to adopt certain regulations;"; in line 15, strike "24-430" and substitute "24-1001 to be under the new subtitle "Subtitle 10. Disclosure of Information to Interested Persons"; after line 20, insert "SUBTITLE 10. DISCLOSURE OF INFORMATION TO INTERESTED PERSONS."; in line 21, strike "24-430." and substitute "24-1001.".

AMENDMENT NO. 2

On page 1, in line 22, after "(A)" insert "EXCEPT AS PROVIDED IN SUBSECTION (B) OF THIS SECTION."; in the same line, strike "AN ENTITY OR" and substitute "A"; strike beginning with the first "OR" in line 23 down through "ARTICLE" in line 24; in line 25, strike "OR ACTION"; in line 27, strike "OR ACTION OR" and substitute "AND".

On page 2, in line 2, strike the second "OR" and substitute "AND"; in line 6, strike "AN ENTITY OR" and substitute "A"; in line 12, strike "ENTITY OR"; in lines 6 and 13, in each instance, strike "VIOLATES" and substitute "VIOLATED"; in lines 8 and 9, in each instance, strike "SUBSECTION (A)" and substitute "SUBSECTION (A) OR (B)"; in lines 6 and 9, respectively, strike "(B)" and "(C)", respectively, and substitute "(C)" and "(D)", respectively; in line 9, after "NOTICE" insert "OR INFORMATION";

after line 5, on page 2, insert:

(Over)

“(B) ON REQUEST, THE SECRETARY SHALL PROVIDE TO A PERSON IN WRITING ANY INFORMATION KNOWN TO THE DEPARTMENT REGARDING A VIOLATION OF THIS ARTICLE THAT RELATES TO THE PRESENCE OF A COMMUNICABLE DISEASE IN AN ENTITY REGULATED BY THE DEPARTMENT IF THE REQUESTING PERSON BELIEVES THAT THE PERSON MAY HAVE CONTRACTED A COMMUNICABLE DISEASE AS A RESULT OF AN INTERACTION WITH AN ENTITY REGULATED BY THE DEPARTMENT.”;

and after line 14, insert:

“(E) THE SECRETARY SHALL ADOPT REGULATIONS TO IMPLEMENT THE PROVISIONS OF THIS SECTION, INCLUDING REGULATIONS TO PROTECT AGAINST UNWARRANTED BREACHES OF CONFIDENTIALITY.”.
