AMENDMENTS TO SENATE BILL NO. 821

(Third Reading File Bill)

AMENDMENT NO. 1

On page 1, strike beginning with "Detention" in line 2 down through "Alternatives" in line 3 and substitute "Juvenile Justice System - Standards"; strike beginning with ", standards" in line 5 down through "Department," in line 7; in line 7, after "alternatives;" insert "requiring the Department to adopt a code of conduct; requiring the Department to require private agencies under contract with the Department to adopt a certain code of conduct;"; in line 15, before "requiring" insert "requiring the Department to adopt regulations that require certain facilities to provide certain programs; providing for the purposes of juvenile detention;"; strike beginning with "to" in line 17 down through "detention" in line 18; and strike beginning with "juvenile" in line 19 down through "alternatives" in line 20 and substitute "the juvenile justice system".

On page 2, in line 3, before "2-134" insert "2-103(c)(7).".

AMENDMENT NO. 2

On page 2, after line 27, insert:

"2-103.

(c) (7) THE DEPARTMENT SHALL:

(I) ADOPT A CODE OF CONDUCT FOR ALL PERSONNEL OF THE DEPARTMENT; AND

(II) REQUIRE PRIVATE AGENCIES UNDER CONTRACT WITH THE DEPARTMENT TO ADOPT A CODE OF CONDUCT FOR PRIVATE AGENCY STAFF THAT IS IN SUBSTANTIAL COMPLIANCE WITH THE CODE OF CONDUCT FOR PERSONNEL OF THE DEPARTMENT.".

(Over)

On page 3, in line 2, after “supervision;” insert “and”; in line 6, after “reveals;” insert “and”; and strike in their entirety lines 7 through 10, inclusive.

On page 5, after line 13, insert:

“(1) A POLICY THAT ELIMINATES THE UNNECESSARY USE OF DETENTION AND PLACES A PRIORITY ON THE USE OF DIVERSION AND APPROPRIATE NONSECURE ALTERNATIVES;”;

in line 16, after “FACILITY” insert “THAT MAY NOT BE EXCEEDED EXCEPT IN EMERGENCY CIRCUMSTANCES DURING WHICH TIME STAFFING RATIOS AND LEVELS OF SERVICES SHALL BE MAINTAINED”; in line 19, after “TRAINING,” insert “INCLUDING TRAINING IN RECOGNIZING AND REPORTING CHILD ABUSE AND NEGLECT,”; in line 21, strike “PROVISIONS REGARDING”; in line 25, after “CHILD;” insert “AND”; strike in their entirety lines 26 and 27; in lines 14, 16, 17, 19, 21, and 24, strike “(1)”, “(2)”, “(3)”, “(4)”, “(5)”, and “(6)”, respectively, and substitute “(2)”, “(3)”, “(4)”, “(5)”, “(6)”, and “(7)”, respectively; strike beginning with “MONITORING” in line 28 down through “OF” in line 29 and substitute “INTERNAL AUDITING AND MONITORING OF PROGRAMS AND FACILITIES IN”; in line 31, strike “(A)”; and in the same line, after “DEVELOP” insert “AND ADOPT REGULATIONS PROVIDING STANDARDS FOR”.

On page 6, strike in their entirety lines 1 through 3, inclusive.
