AMENDMENT NO. 1

On page 1, strike beginning with "Detention" in line 2 down through "Alternatives" in line 3 and substitute "Juvenile Justice System - Standards"; strike beginning with "<u>standards</u>" in line 5 down through "Department," in line 7; in line 7, after "alternatives;" insert "requiring the Department to adopt a code of conduct; requiring the Department to require private agencies under contract with the Department to adopt a certain code of conduct;"; in line 15, before "requiring" insert "requiring the Department to adopt a certain programs; providing for the purposes of juvenile detention;"; strike beginning with "to" in line 17 down through "detention" in line 18; and strike beginning with "juvenile" in line 19 down through "alternatives" in line 20 and substitute "the juvenile justice system".

On page 2, in line 3, before "<u>2-134</u>" insert "<u>2-103(c)(7)</u>,".

AMENDMENT NO. 2

On page 2, after line 27, insert:

"<u>2-103.</u>

(c) (7) THE DEPARTMENT SHALL:

(I) ADOPT A CODE OF CONDUCT FOR ALL PERSONNEL OF THE DEPARTMENT; AND

(II) REQUIRE PRIVATE AGENCIES UNDER CONTRACT WITH THE DEPARTMENT TO ADOPT A CODE OF CONDUCT FOR PRIVATE AGENCY STAFF THAT IS IN SUBSTANTIAL COMPLIANCE WITH THE CODE OF CONDUCT FOR PERSONNEL OF THE DEPARTMENT.".

On page 3, in line 2, after "supervision;" insert "<u>and</u>"; in line 6, after "reveals;" insert "<u>and</u>"; and strike in their entirety lines 7 through 10, inclusive.

On page 5, after line 13, insert:

"(1) <u>A POLICY THAT ELIMINATES THE UNNECESSARY USE OF</u> <u>DETENTION AND PLACES A PRIORITY ON THE USE OF DIVERSION AND APPROPRIATE</u> <u>NONSECURE ALTERNATIVES;</u>";

in line 16, after "FACILITY" insert "<u>THAT MAY NOT BE EXCEEDED EXCEPT IN</u> <u>EMERGENCY CIRCUMSTANCES DURING WHICH TIME STAFFING RATIOS AND LEVELS</u> <u>OF SERVICES SHALL BE MAINTAINED</u>"; in line 19, after "TRAINING," insert "<u>INCLUDING</u> <u>TRAINING IN RECOGNIZING AND REPORTING CHILD ABUSE AND NEGLECT</u>,"; in line 21, strike "PROVISIONS REGARDING"; in line 25, after "CHILD;" insert "<u>AND</u>"; strike in their entirety lines 26 and 27; in lines 14, 16, 17, 19, 21, and 24, strike "(1)", "(2)", "(3)", "(4)", "(5)", and "(6)", respectively, and substitute "(2)", "(3)", "(4)", "(5)", "(6)", and "(7)", respectively; strike beginning with "MONITORING" in line 28 down through "OF" in line 29 and substitute "<u>INTERNAL AUDITING AND MONITORING OF PROGRAMS AND FACILITIES IN</u>"; in line 31, strike "(A)"; and in the same line, after "DEVELOP" insert "<u>AND ADOPT REGULATIONS</u> <u>PROVIDING STANDARDS FOR</u>".

On page 6, strike in their entirety lines 1 through 3, inclusive.
