AMENDMENTS TO HOUSE BILL NO. 62

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike "Delegates Leopold, Sophocleus, and Love" and substitute "Anne Arundel County Delegation"; in line 8, after "conditions;" insert "authorizing the Board of License Commissioners to issue a Class H (beer and wine) license to a person who independently owns and operates a restaurant that is part of a common franchise corporate entity under certain conditions;".

AMENDMENT NO. 2

On page 2 in line 22, and on page 3 in line 10, in each instance, strike "OR"; and on page 2 in line 25, and on page 3 in line 13, in each instance, after "CODE" insert "; OR

F. THE ROUTE 198 CORRIDOR, CONSISTING OF PROPERTIES LOCATED WITHIN 500 FEET OF THE RIGHT-OF-WAY OF MARYLAND ROUTE 198, FROM ROUTE 32 ON THE EAST TO THE PRINCE GEORGE'S COUNTY-ANNE ARUNDEL COUNTY LINE ON THE WEST".

AMENDMENT NO. 3

On page 3, after line 13, insert:

"(3) A PERSON WHO INDEPENDENTLY OWNS AND OPERATES A RESTAURANT THAT IS PART OF A COMMON FRANCHISE CORPORATE ENTITY MAY:

(I) BE ISSUED ONLY ONE CLASS H (BEER AND WINE) LICENSE BY THE ANNE ARUNDEL COUNTY BOARD OF LICENSE COMMISSIONERS IF THE PERSON DID NOT HOLD A RETAIL ALCOHOLIC BEVERAGES LICENSE IN ANNE ARUNDEL COUNTY ON JANUARY 1, 2000; OR

(Over)

(II) BE ISSUED ONE ADDITIONAL CLASS H (BEER AND WINE) LICENSE BY THE ANNE ARUNDEL COUNTY BOARD OF LICENSE COMMISSIONERS, IN ACCORDANCE WITH PARAGRAPH (1) OF THIS SUBSECTION, IF THE PERSON HELD A CLASS H (BEER AND WINE) LICENSE IN ANNE ARUNDEL COUNTY ON JANUARY 1, 2000.”;

and in lines 14 and 16, strike “(3)” and “(4)”, respectively, and substitute “(4)” and “(5)”, respectively.

AMENDMENT NO. 4

On page 3, in line 14, after “THE” insert “ANNE ARUNDEL COUNTY”.

AMENDMENT NO. 5

On page 4, in line 9, strike “October” and substitute “July”.
