(First Reading File Bill)

On page 1, in the sponsor line, strike "and Hogan" and substitute ", Hogan, Lawlah, Madden, McFadden, Munson, Ruben, and Van Hollen".

On page 5, after line 4, insert:

- "(G) A COMMUNITY COLLEGE THAT RECEIVES MONEY UNDER THIS SUBTITLE TO ESTABLISH JOB TRAINING ADVANCE ACCOUNTS SHALL:
- (1) ASSIST INDIVIDUALS WHO PURSUE APPROVED JOB TRAINING PROGRAMS IN OBTAINING EMPLOYMENT UPON COMPLETION OF THE PROGRAM;
 - (2) MONITOR AND COLLECT DATA REGARDING:
- (I) THE NUMBER OF INDIVIDUALS WHO SUCCESSFULLY COMPLETE AN APPROVED JOB TRAINING PROGRAM;
- (II) THE NUMBER OF INDIVIDUALS WHO OBTAIN EMPLOYMENT AFTER COMPLETING AN APPROVED JOB TRAINING PROGRAM AND THE WAGES THAT ARE RECEIVED BY THESE INDIVIDUALS; AND
- (III) THE EXTENT TO WHICH INDIVIDUALS WHO OBTAIN EMPLOYMENT AFTER PURSUING APPROVED JOB TRAINING PROGRAMS RETAIN EMPLOYMENT UPON COMPLETION OF THE PROGRAM; AND
- (3) SUBMIT A REPORT TO THE COMMISSION NO LATER THAN OCTOBER 31 OF EACH YEAR THAT SUMMARIZES THE INFORMATION COLLECTED UNDER PARAGRAPH (2) OF THIS SUBSECTION.";

in line 23, strike "AND"; and in line 26, after "PROGRAMS" insert ";

- (IV) THE NUMBER OF ELIGIBLE INDIVIDUALS WHO HAVE SUCCESSFULLY COMPLETED AN APPROVED JOB TRAINING PROGRAM;
- (V) THE NUMBER OF ELIGIBLE INDIVIDUALS WHO HAVE OBTAINED EMPLOYMENT AFTER COMPLETING AN APPROVED JOB TRAINING PROGRAM AND THE WAGES THAT ARE RECEIVED BY THESE INDIVIDUALS; AND
- (VI) THE EXTENT TO WHICH ELIGIBLE INDIVIDUALS WHO OBTAIN EMPLOYMENT AFTER PURSUING APPROVED JOB TRAINING PROGRAMS RETAIN EMPLOYMENT UPON COMPLETION OF THE PROGRAM".
