AMENDMENTS TO SENATE BILL NO. 552

(Third Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 3, after "of" insert "<u>requiring certain providers of taxicab services licensed after a certain date to obtain certain training in a manner approved by the Commission;</u>"; in line 10, after "<u>Services;</u>" insert "<u>requiring certain fees for certain record checks;</u>".

AMENDMENT NO. 2

On page 4, in line 24, strike "AND" and substitute "OR".

On page 9, in line 26, after "(6)" insert "(I)"; after line 31, insert:

- "(II) AN APPLICANT WHO IS REQUIRED BY THE COMMISSION TO OBTAIN A CRIMINAL HISTORY RECORDS CHECK FROM THE FEDERAL BUREAU OF INVESTIGATION UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH SHALL:
- 1. APPLY TO THE CRIMINAL JUSTICE INFORMATION SYSTEM CENTRAL REPOSITORY OF THE DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES FOR A NATIONAL CRIMINAL HISTORY RECORDS CHECK;
- 2. SUBMIT TO THE CRIMINAL JUSTICE INFORMATION SYSTEM CENTRAL REPOSITORY ONE COMPLETE SET OF THE APPLICANT'S LEGIBLE FINGERPRINTS TAKEN ON FORMS APPROVED BY THE DIRECTOR OF THE FEDERAL BUREAU OF INVESTIGATION; AND
- 3. SUBMIT TO THE CRIMINAL JUSTICE INFORMATION SYSTEM CENTRAL REPOSITORY THE MANDATORY PROCESSING FEE REQUIRED BY THE FEDERAL BUREAU OF INVESTIGATION FOR A NATIONAL CRIMINAL HISTORY RECORDS CHECK.".

On page 10, after line 4, insert:

- "(D) (1) THIS SUBSECTION APPLIES ONLY IN BALTIMORE CITY.
- (2) ON OR BEFORE JULY 1, 2002, AN INDIVIDUAL APPLYING FOR A TAXICAB LICENSE OR RENEWAL OF A TAXICAB LICENSE, SHALL SUBMIT PROOF OF HAVING SUCCESSFULLY COMPLETED A COURSE APPROVED BY THE COMMISSION THAT INCLUDES IN THE CURRICULUM:
 - (I) COURTEOUS TREATMENT OF PASSENGERS;
- (II) GEOGRAPHY AND MAP READING FOR THE JURISDICTION IN WHICH THE TAXICAB SERVICES WILL BE PROVIDED; AND
- (III) TOURIST INFORMATION FOR THE JURISDICTION IN WHICH TAXICAB SERVICES WILL BE PROVIDED.";

in line 13, strike "(d)" and substitute "<u>(E)</u>"; and strike beginning with "AND" in line 22 down through "ARTICLE" in line 23.
