AMENDMENT NO. 1

On page 1, strike beginning with "specifying" in line 12 down through "effect;" in line 14; in line 16, after "Program;" insert "providing for the recapture of a tax credit under certain circumstances;"; and in line 17, strike "providing for the termination of this Act;".

AMENDMENT NO. 2

On page 3, in lines 18 and 19 and in lines 33 and 34, in each instance, strike "10 YEARS FROM THE EFFECTIVE DATE OF THIS SUBTITLE" and substitute "<u>UNTIL SEPTEMBER 30</u>, 2010".

AMENDMENT NO. 3

On page 4, in line 6, strike "INDICATING THE FACILITY'S INTENT"; and after line 7, insert:

"(4) THE DEPARTMENT IS NOT REQUIRED TO ACT ON AN APPLICATION THAT IS RECEIVED WHEN A DROUGHT EMERGENCY IS IN EFFECT IN THE AREA IN WHICH THE CAR WASH IS LOCATED.".

AMENDMENT NO. 4

On page 4, in lines 9 and 11, strike "\$50" and "\$25", respectively, and substitute "<u>\$60</u>" and "<u>\$35</u>", respectively; in line 10, after "(2)" insert "<u>FOR EACH YEAR THE FACILITY CONTINUES</u> <u>TO PARTICIPATE IN THE PROGRAM,</u>"; in the same line, after "SHALL" insert "<u>: (I)</u>"; in lines 11 and 12, strike "FOR EACH YEAR THE FACILITY CONTINUES TO PARTICIPATE IN THE PROGRAM" and substitute "; AND

(II) PROVIDE DOCUMENTATION TO THE DEPARTMENT THAT

EEA

THE FACILITY HAS COMPLIED WITH THE APPLICABLE PROVISIONS OF § 5-1402(B), (C), AND (D) OF THIS SUBTITLE AND SUBSECTION (C) OF THIS SECTION";

and in line 23, strike "DURING AN INSPECTION".

AMENDMENT NO. 5

On page 4, strike beginning with "A" in line 13 down through "(D)" in line 16.

AMENDMENT NO. 6

On page 4, in line 29, after "CIRCUMSTANCES;" insert "AND"; and strike beginning with "; AND" in line 31 down through "REPAIRED" in line 33; and after line 33, insert:

"(C) IF THE DEPARTMENT DISCOVERS THAT AN OWNER OR OPERATOR OF A CERTIFIED FACILITY HAS WILLFULLY FAILED TO COMPLY WITH § 5-1402(D)(2) OR (E)(3) OF THIS SUBTITLE, ANY TAX CREDIT RECEIVED UNDER § 10-718 OF THE TAX - GENERAL ARTICLE SHALL BE RECAPTURED AS PROVIDED FOR IN THAT SECTION."

On page 7, after line 26, insert:

"(F) FOR ANY TAXABLE YEAR, IF THE OWNER OR OPERATOR OF A CERTIFIED CAR WASH FACILITY WILLFULLY FAILS TO COMPLY WITH § 5-1402(D)(2) OR (E)(3) OF THE ENVIRONMENT ARTICLE, THE TAX CREDIT PREVIOUSLY ALLOWED UNDER THIS SECTION SHALL BE RECAPTURED.";

in line 27, strike "(F)" and substitute "(G)"; and strike beginning with "It" in line 34 down through "effect." in line 36.

AMENDMENT NO. 7

On page 6, in line 23, strike "REGULATIONS" and substitute "<u>RESTRICTIONS</u>"; and in line 34, after "SECTION," insert "<u>THE OWNER OF</u>".
