AMENDMENT NO. 2

On page 2, in line 17, after "CHILDREN'S" insert "<u>ENVIRONMENTAL</u>"; in line 18, strike "ENVIRONMENTAL"; in lines 19 and 20, strike "EXPOSURE TO HARMFUL CHEMICALS AND" and substitute "<u>ONE OR A GROUP OF TOXIC CHEMICAL, BIOLOGICAL, OR PHYSICAL AGENTS IN THE ENVIRONMENT, RESULTING FROM HUMAN ACTIVITIES OR NATURAL PROCESSES, THAT MAY IMPACT THE HEALTH OF EXPOSED CHILDREN, INCLUDING SUCH"; in line 20, strike "SUCH"; in line 21, strike "DUMPS"; in line 22, after "SMOKE," insert "<u>AND</u>"; in the same line after "INDUSTRIAL" insert "<u>AND HOME</u>"; strike beginning with ", AND" in line 22 down through "HEALTH" in line 23; in line 29, after "(2)" insert "<u>IN CERTAIN CASES</u>"; in line 31, after "DETOXIFY" insert "<u>CERTAIN</u>"; and in line 34, strike "WEAKER" and substitute "<u>IMMATURE</u>".</u>

On page 3, in line 5, strike "INGEST" and substitute "<u>TAKE IN</u>"; in line 11, strike the second "AND"; in line 15, after "POLICY" insert "<u>; AND</u>

(XV) ONE ENVIRONMENTAL TOXICOLOGIST WITH EXPERTISE IN ISSUES OF IMPORTANCE TO CHILDREN'S ENVIRONMENTAL HEALTH, APPOINTED BY THE GOVERNOR;

(XVI) ONE REPRESENTATIVE FROM THE MARYLAND ASSOCIATION OF COUNTIES, APPOINTED BY THE GOVERNOR; AND

(XVII) ONE INDIVIDUAL FROM PRIVATE INDUSTRY REPRESENTING THE REGULATED COMMUNITY, APPOINTED BY THE GOVERNOR";

strike beginning with "AND" in line 31 down through "DESIGNEE" in line 32; in line 32, strike "COCHAIRS" and substitute "<u>THE CHAIRMAN</u>"; and after line 32, insert:

"(3) <u>THE SECRETARY OF THE ENVIRONMENT OR THE SECRETARY'S</u> DESIGNEE SHALL SERVE AS THE VICE CHAIRMAN.".

On page 5, strike lines 7 through 18, inclusive; strike beginning with the colon in line 23 down through "(2)" in line 25; strike beginning with "THE" in line 27 down through "BUDGET" in line 28 and substitute "<u>THE DEPARTMENT OF HEALTH AND MENTAL HYGIENE SHALL</u> <u>COORDINATE WITH THE DEPARTMENT OF THE ENVIRONMENT AND OTHER STATE</u> <u>AGENCIES TO PROVIDE FOR STAFFING OF THE ADVISORY COUNCIL</u>"; strike beginning with "DETERMINE" in line 29 down through "AND," in line 30 and substitute "<u>EMPLOY</u> <u>CONSULTANTS</u>"; in line 30, strike ", COMPENSATION FOR STAFF"; after line 30, insert:

"(E) (1) THE ADVISORY COUNCIL MAY CONTRACT FOR AN ANALYSIS OF THE CURRENT STATE ORGANIZATIONAL STRUCTURE REGARDING CHILDREN'S ENVIRONMENTAL HEALTH AND PROTECTION.

(2) AN ANALYSIS UNDER THIS SUBSECTION SHALL BE PERFORMED IN A MANNER CONSISTENT WITH THE RECOMMENDATION OF THE ADVISORY COUNCIL ON ENVIRONMENTAL JUSTICE CONTAINED IN THE COUNCIL'S REPORT DATED NOVEMBER 1999.";

On page 6, strike beginning with "AND" in line 4 down through "CHILDREN;" in line 8.

On page 6, in lines 1 and 12, in each instance, after "CHILDREN" insert "FROM ENVIRONMENTAL HAZARDS"; in line 9, strike "AND COMMENT ON"; and in line 34, strike

On page 8, in line 30, strike the brackets; and strike in their entirety lines 31 and 32; and in line 33, strike the brackets and "(III)".
