AMENDMENT NO. 3

On page 5, in line 17, after "CONVENE" insert "<u>A CRISIS IN NURSING SUMMIT</u>"; and after line 20, insert "<u>IN ADDITION TO THE ISSUES IDENTIFIED AND PRIORITIZED AS A RESULT OF THE SUMMIT CONVENED UNDER ITEM (1) OF THIS SUBSECTION,</u>".

On page 6, strike beginning with " \underline{A} " in line 10 down through " $\underline{(F)}$ " in line 14; in line 16, strike "(G)" and substitute "(F)"; and after line 20, insert:

"(G) A MEMBER OF THE COMMISSION MAY NOT RECEIVE COMPENSATION
BUT IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER THE STANDARD
TRAVEL REGULATIONS, AS PROVIDED IN THE STATE BUDGET.".
