## AMENDMENTS TO HOUSE BILL NO. 194 (First Reading File Bill)

### AMENDMENT NO. 1

On page 1, in line 3, after "State;" insert "<u>establishing that this Act does not create, and may</u> not be construed as creating, a new cause of action or substantive legal right for foster parents;".

### AMENDMENT NO. 2

On page 2, in line 2, strike "PLACEMENT AGENCY PLAN" and substitute "<u>FOSTER</u> <u>PARENT'S RESPONSIBILITIES</u>"; in line 3, strike "A" and substitute "<u>THE</u>"; and in the same line, after "PARENT" insert "<u>IN A MANNER</u>".

### AMENDMENT NO. 3

On page 2, in line 24, strike "ANY ELEMENT OF"; in the same line, strike "CASE WORKER" and substitute "<u>CASEWORKER</u>, <u>EXCEPT FOR INFORMATION ABOUT THE</u> <u>FAMILY MEMBERS THAT MAY BE PRIVILEGED OR CONFIDENTIAL</u>,"; and in line 25, strike "COULD" and substitute "<u>WOULD</u>".

On page 3, in line 14, strike "MAY" and substitute "SHALL".

### AMENDMENT NO. 4

On page 2, in line 27, after the first "TO" insert "<u>THE LOCAL DEPARTMENT OF SOCIAL</u> <u>SERVICES</u>"; in line 30, after "PARTICIPATE" insert "<u>WITHOUT SUPERSEDING THE RIGHTS</u> <u>OF THE NATURAL PARENTS TO PARTICIPATE AND MAKE APPROPRIATE DECISIONS</u> <u>REGARDING THE CHILD</u>,"; in line 32, after "MEETINGS;" insert "<u>AND</u>"; and strike beginning with "AND" in line 34 down through "TEAM;" in line 38.

## On page 3, in line 10, after "REVIEWS" insert "<u>, PROVIDED THAT A FOSTER PARENT</u> MAY NOT BE CONSIDERED TO BE A PARTY SOLELY ON THE BASIS OF THE NOTICE

#### AMENDMENT NO. 6

On page 3, in lines 16 and 17, strike ": (I)"; in line 20, after "PARENT" insert "<u>AND IS</u> <u>CONSISTENT WITH THE PROVISIONS OF § 5-534(C) OF THIS SUBTITLE</u>"; and strike in their entirety lines 21 through 23, inclusive.

### AMENDMENT NO. 7

On page 1, in line 14, before "FOSTER" insert "(A)".

On page 3, after line 27, insert:

# "(B) THIS SECTION DOES NOT CREATE, AND MAY NOT BE CONSTRUED AS CREATING, A NEW CAUSE OF ACTION OR SUBSTANTIVE LEGAL RIGHT FOR FOSTER PARENTS.".
