## AMENDMENTS TO HOUSE BILL NO. 417

(Third Reading File Bill)

## AMENDMENT NO. 1

On page 1, strike beginning with "causes" in line 5 down through "property" in line 8 and substitute "while driving a motor vehicle during a single traffic incident commits at least a certain number of motor vehicle violations and causes the death of another person as a result of the person's negligent driving of the motor vehicle"; in line 10, before "providing" insert "specifying certain violations to which the crime of homicide by aggressive driving applies;"; and in line 12, before "and" insert "defining a certain term;".

## AMENDMENT NO. 2

On page 3 , strike in their entirety lines 8 through 13, inclusive, and substitute:
"(A) IN THIS SECTION, "SINGLE TRAFFIC INCIDENT" MEANS AN ACCIDENT THAT OCCURS WITHIN THE SAME COURSE OF CONDUCT AND DURING THE CONTINUOUS OPERATION OF A MOTOR VEHICLE WITHOUT INTERRUPTION.
(B) A PERSON IS GUILTY OF HOMICIDE BY AGGRESSIVE DRIVING IF, WHILE DRIVING A MOTOR VEHICLE DURING A SINGLE TRAFFIC INCIDENT, THE PERSON:
(1) COMMITS TWO OR MORE OF THE VIOLATIONS THAT ARE SPECIFIED IN SUBSECTION (C) OF THIS SECTION; AND
(2) CAUSES THE DEATH OF ANOTHER PERSON AS A RESULT OF THE PERSON'S NEGLIGENT DRIVING OF THE MOTOR VEHICLE.
(C) THIS SECTION APPLIES TO VIOLATIONS OF THE FOLLOWING PROVISIONS OF THE TRANSPORTATION ARTICLE:
(1) §21-201 ("OBEDIENCE TO TRAFFIC CONTROL DEVICES");
(2) §21-202 ("TRAFFIC LIGHTS WITH STEADY INDICATION");
(3) §21-301 ("DRIVING ON THE RIGHT SIDE OF ROADWAY");
(4) §21-303 ("OVERTAKING AND PASSING VEHICLES");
(5) § 21-308 ("ONE-WAY TRAFFIC AND ROTARY TRAFFIC ISLANDS");
(6) §21-309 ("DRIVING ON LANED ROADWAYS");
(7) §21-310 ("FOLLOWING TOO CLOSELY");
(8) § 21-402 ("TURNING LEFT OR MAKING U-TURN");
(9) §21-502 ("PEDESTRIANS' RIGHT-OF-WAY IN CROSSWALKS");
(10) § 21-504 ("DRIVER'S DUTY TO EXERCISE DUE CARE TO AVOID PEDESTRIANS");
(11) §21-602 ("U-TURN ON CURVE OR CREST OF GRADE");
(12) § 21-706 ("OVERTAKING AND PASSING SCHOOL VEHICLE");
(13) §21-707 ("STOP SIGNS AND YIELD SIGNS");
(14) §21-801.1 ("MAXIMUM LIMITS") FOR VIOLATIONS THAT INVOLVE SPEEDING IN EXCESS OF THE POSTED SPEED LIMIT BY 10 MILES PER HOUR OR MORE;
(15) §21-1102 ("LIMITATIONS ON BACKING");
(16) §21-1121 ("CHILDREN IN REAR OF PICK UP TRUCKS"); AND
(17) §21-1209("THROWING OBJECT AT BICYCLIST; OPENING DOOR OF MOTOR VEHICLE").";
in line 14 , strike " $(\mathbf{B})$ " and substitute "( $\mathbf{D})$ "; in line 23, strike " $(\mathbf{C})$ " and substitute " $(\mathrm{E})$ "; in line 27,

strike "(D)" and substitute "(F)"; in lines 28 and 29, strike "IN THE PENITENTIARY"; in line 29, strike "3 YEARS" and substitute " 1 YEAR"; and in the same line, strike " $\$ 5,000$ " and substitute " $\$ 1,000$ ".
