AMENDMENT NO. 3

On page 2, in line 24, strike "CASE WORKER ON ANY ELEMENT OF" and substitute "CASEWORKER, EXCEPT FOR INFORMATION ABOUT THE FAMILY MEMBERS THAT MAY BE PRIVILEGED OR CONFIDENTIAL, ON"; and in line 25, strike "COULD" and substitute "WOULD".

AMENDMENT NO. 4

On page 2, in line 27, after the first "TO" insert "THE LOCAL DEPARTMENT OF SOCIAL SERVICES"; in line 28, after "(I)" insert "EXCEPT FOR MEETINGS COVERED BY THE ATTORNEY-CLIENT PRIVILEGE OR MEETINGS IN WHICH CONFIDENTIAL INFORMATION ABOUT THE NATURAL PARENTS IS DISCUSSED,"; in line 30, after "PARTICIPATE" insert ", WITHOUT SUPERSEDING THE RIGHTS OF THE NATURAL PARENTS TO PARTICIPATE AND MAKE APPROPRIATE DECISIONS REGARDING THE CHILD,"; and strike beginning with "IN" in line 36 down through "TEAM" in line 38 and substitute "BY THE LOCAL DEPARTMENT OF SOCIAL SERVICES".

AMENDMENT NO. 5

On page 3, in line 10, after "REVIEWS" insert ", PROVIDED THAT A FOSTER PARENT
