- 3 FOR the purpose of requiring certain individuals who have personal knowledge of the
- 4 death of another or who have personally discovered the body of another

- 20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 21 MARYLAND, That the Laws of Maryland read as follows:

- In this title, "body" means a dead human body.

- 2 (A) THIS SECTION APPLIES ONLY TO AN INDIVIDUAL WHO:
- 3 (1) HAS PERMANENT OR TEMPORARY CARE OR CUSTODY OR
- 4 RESPONSIBILITY FOR SUPERVISION OR CARE OF THE INDIVIDUAL WHO IS THE
- 5 DECEASED;
- 6 (2) IS A SPOUSE, PARENT, OR ADULT CHILD OF THE DECEASED; OR
- 7 (3) IS A MEMBER OF THE HOUSEHOLD OF THE DECEASED.
- 8 (B) SUBJECT TO SUBSECTION (C) OF THIS SECTION, AN INDIVIDUAL WHO HAS
- 9 PERSONAL KNOWLEDGE OF THE DEATH OF ANOTHER INDIVIDUAL OR WHO HAS
- 10 PERSONALLY DISCOVERED THE BODY OF ANOTHER INDIVIDUAL SHALL PROVIDE, IN
- 11 PERSON OR BY TELEPHONE, NOTICE OF THE DEATH WITHIN 24 HOURS AFTER
- 12 ACQUIRING PERSONAL KNOWLEDGE OR DISCOVERY OF THE DEATH TO:
- 13 (1) A LAW ENFORCEMENT OFFICER AS DEFINED IN ARTICLE 27, § 727 OF 14 THE CODE;
- 15 (2) A PHYSICIAN WHO HAS PROVIDED MEDICAL TREATMENT TO THE
- $16\,$ DECEASED INDIVIDUAL WITHIN $30\,$ DAYS PRIOR TO THE KNOWLEDGE OR DISCOVERY

- 18 (3) A 911 SYSTEM OR PUBLIC SAFETY ANSWERING POINT AS THOSE
- 19 TERMS ARE DEFINED IN ARTICLE 41, § 18-101 OF THE CODE; OR
- 20 (4) A MEDICAL EXAMINER.
- 21 (C) SUBSECTION (B) OF THIS SECTION DOES NOT APPLY TO AN INDIVIDUAL
- 22 WHO HAS A REASONABLE BELIEF THAT NOTICE OF THE DEATH HAS BEEN
- 23 PREVIOUSLY MADE UNDER SUBSECTION (B) OF THIS SECTION.
- 24 (D) AN INDIVIDUAL WHO FAILS TO PROVIDE NOTICE AS REQUIRED UNDER
- 25 SUBSECTION (B) OF THIS SECTION IS GUILTY OF A MISDEMEANOR AND ON
- 26 CONVICTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 1 YEAR OR A FINE NOT
- 27 EXCEEDING \$500 OR BOTH.
- 28 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
