CHAPTER _____

1 AN ACT concerning

2 **Maryland Science and Technology Scholarships**

3 FOR the purpose of requiring the State Scholarship Administration to offer Maryland
4 Science and Technology Scholarships to certain students currently enrolled in
5 certain undergraduate programs under certain circumstances and during a
6 certain period of time; requiring the Administration to allocate certain funds
7 between certain groups of students; establishing certain requirements for
8 certain undergraduate students to receive a Maryland Science and Technology
9 Scholarship; requiring the Administration to establish certain procedures; and
10 generally relating to the Maryland Science and Technology Scholarship
11 Program.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
18 MARYLAND, That the Laws of Maryland read as follows:

Article - Education

2 18-2002.

3 (a) There is a program of Maryland Science and Technology Scholarships in
4 this State that are awarded under this subtitle. [The] EXCEPT AS PROVIDED IN
5 SUBSECTION (B) OF THIS SECTION, THE Administration shall annually select
6 secondary school students who have the greatest potential for academic success in
7 higher education and offer a scholarship to each student to be used at a Maryland
8 higher education institution of their choice, if the recipient meets the following
9 qualifications:

10 (1) Qualifies academically as follows:

11 (i) Has a secondary school transcript indicating an overall
12 academic grade point average of at least 3.0 on a 4.0 scale or its equivalent grade
13 point average in core curriculum courses after completion of the first semester of the
14 senior year;

15 (ii) Intends to enroll as a full-time student in an academic program
16 as designated by the Maryland Higher Education Commission; and

17 (iii) Has graduated from a secondary school;

18 (2) Is a Maryland resident and was a Maryland resident at the time of
19 graduating from secondary school;

20 (3) Is accepted for admission in a regular undergraduate program at a
21 Maryland higher education institution in the State;

22 (4) Begins attending an eligible Maryland higher education institution
23 within 2 years of completing high school or, failing to do so, provides evidence
24 satisfactory to the State Scholarship Administration of extenuating circumstances;

25 (5) Agrees to the conditions provided in subsection [(c)] (D) of this
26 section; and

27 (6) Accepts any other conditions attached to the award and satisfies any
28 additional criteria the Commission may establish.

29 (B) (1) AFTER SEPTEMBER 1 AND BEFORE OCTOBER 31 OF EACH YEAR, IF
30 FUNDS REMAIN AFTER COMPLETING AWARDS TO ELIGIBLE STUDENTS UNDER
31 SUBSECTION (A) OF THIS SECTION, THE ADMINISTRATION SHALL ALLOCATE THE
32 FUNDS TO STUDENTS CURRENTLY ENROLLED IN AN UNDERGRADUATE PROGRAM AT
33 AN INSTITUTION OF HIGHER EDUCATION IN THE STATE WHO HAVE THE GREATEST
34 POTENTIAL FOR ACADEMIC SUCCESS IN HIGHER EDUCATION AS FOLLOWS:

35 (I) 50% OF THE FUNDS TO STUDENTS WHO ARE IN THE FOURTH
36 YEAR OF A 4-YEAR PROGRAM; AND

1 (II) 50% OF THE FUNDS TO STUDENTS WHO ARE IN THE SECOND
2 YEAR OF A 2-YEAR PROGRAM.

3 (2) TO THE EXTENT FUNDS ARE AVAILABLE AND IN ACCORDANCE WITH
4 PARAGRAPH (1) OF THIS SUBSECTION, THE ADMINISTRATION SHALL OFFER A
5 SCHOLARSHIP TO EACH STUDENT TO BE USED AT AN INSTITUTION OF HIGHER
6 EDUCATION IN THE STATE, IF THE STUDENT:

7 (I) HAS EARNED A CUMULATIVE GRADE POINT AVERAGE OF AT
8 LEAST 3.0 ON A 4.0 SCALE OR ITS EQUIVALENT AS CALCULATED AND INDICATED ON A
9 COLLEGE TRANSCRIPT AFTER THE LAST COMPLETED SEMESTER BEFORE THE
10 APPLICATION WAS SUBMITTED;

11 (II) IS ENROLLED AS A FULL-TIME STUDENT IN AN ACADEMIC
12 PROGRAM AS DESIGNATED BY THE COMMISSION;

13 (III) IS A MARYLAND RESIDENT AND WAS A MARYLAND RESIDENT
14 AT THE TIME OF GRADUATING FROM SECONDARY SCHOOL;

15 (IV) AGREES TO THE CONDITIONS PROVIDED IN SUBSECTION (D) OF
16 THIS SECTION; AND

17 (V) ACCEPTS ANY OTHER CONDITIONS ATTACHED TO THE AWARD
18 AND SATISFIES ANY ADDITIONAL CRITERIA THE COMMISSION MAY ESTABLISH.

19 [(b)] (C) (1) The annual scholarship award shall be in the amount of \$1,000
20 for a student enrolled at a 2-year eligible institution or \$3,000 for a student enrolled
21 at a 4-year eligible institution.

22 (2) (I) THIS PARAGRAPH DOES NOT APPLY TO A STUDENT WHO
23 RECEIVES AN AWARD IN ACCORDANCE WITH SUBSECTION (B) OF THIS SECTION.

24 (II) If accepted by the eligible student, each award may be renewed
25 on an annual basis for a maximum of 3 years after the original award if the recipient:

26 [(i)] 1. Remains a resident of the State;

27 [(ii)] 2. Attends a Maryland higher education institution in the
28 State;

29 [(iii)] 3. Is enrolled as a full-time undergraduate student and
30 takes at least 12 semester hours of courses each semester or its equivalent as
31 determined by the Administration;

32 [(iv)] 4. Maintains a 3.0 grade point average on an academic year
33 basis or, failing to do so, provides evidence satisfactory to the Administration, of
34 extreme extenuating circumstances;

35 [(v)] 5. Is making satisfactory progress toward a degree as
36 determined by the institution; and

1 [(vi)] 6. Maintains the standards of the institution.

2 (3) Subject to the provisions of paragraph (2) of this subsection, each
3 recipient of a Maryland Science and Technology Scholarship who is enrolled in a
4 baccalaureate degree program may renew the annual award four times if the
5 recipient is enrolled in an undergraduate academic program that, as determined by
6 the institution, requires 5 years to complete.

7 (4) Subject to the provisions of paragraph (2) of this subsection, each
8 award may be renewed on an annual basis for a maximum of 2 years for students
9 enrolled in an associate degree program.

10 (5) A RECIPIENT OF AN AWARD UNDER SUBSECTION (B) OF THIS
11 SECTION MAY NOT RENEW THE AWARD.

12 [(c)] (D) A recipient of an award made under this section shall receive the
13 award for each year indicated in which the recipient is eligible if:

14 (1) The recipient signs an agreement at the time of the initial award to:

15 (i) Commence employment in the State within 1 year after
16 completion of undergraduate studies for 1 year for each year that the scholarship was
17 awarded; and

18 (ii) Repay the State the amounts awarded under this subtitle and
19 simple interest equal to the prime rate of interest plus 2 percent calculated from the
20 date of the first payment of the grant award under this subtitle for any portion of the
21 award if the recipient does not:

22 1. Satisfy the degree requirements of the eligible academic
23 program or fulfill other requirements as provided in this subtitle; and

24 2. Perform the service obligation for 1 year for each year that
25 the recipient has a scholarship awarded under this subtitle; and

26 (2) The service obligation begins after graduation and cannot be fulfilled
27 prior to graduation from an eligible institution.

29 The State Scholarship Administration shall:

30 (1) [publicize] PUBLICIZE the availability of Maryland Science and
31 Technology Scholarships; AND

32 (2) ESTABLISH PROCEDURES TO IMPLEMENT THE REQUIREMENTS OF §
33 18-2002(B) OF THIS SUBTITLE, INCLUDING PROCEDURES FOR:

34 (I) PUBLICIZING THE AVAILABILITY OF FUNDS REMAINING AFTER
35 COMPLETING AWARDS TO ALL ELIGIBLE HIGH SCHOOL STUDENTS;

1 (II) DISTRIBUTING APPLICATIONS TO STUDENTS CURRENTLY
2 ENROLLED IN UNDERGRADUATE PROGRAMS IN THE STATE AND ACCEPTING
3 APPLICATIONS FROM THOSE STUDENTS; AND

4 (III) RANKING AND MAKING AWARDS TO ELIGIBLE
5 UNDERGRADUATE STUDENTS.

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
7 June 1, 2000.
